Cramahe man pleads guilty to impaired driving causing death

COBOURG — Cramahe Township resident Adrian P. Grenon, 62, pleaded guilty to impaired driving causing death in the Ontario Court of Justice in Cobourg yesterday.

Ongoing medical treatment from the Sept. 3, 2008 crash, in which his passenger, Ray Bull of Colborne, died, will force sentencing several months into the future, however,

The crash occurred on County Road 2 in Alnwick-Haldimand Township at about 5:45 p.m. that day, Crown attorney Brad Kelneck said. A farmer had just left his barn on the south side of the highway when he heard a crash and called 911. Police arriving at 6:09 p.m. found fire fighters and paramedics already attending to the occupant of an upside-down grey motor vehicle adjacent to that barn.

Upon further investigation, they learned Grenon had a male passenger who had died from a broken neck.

Police spoke with Grenon to ask if it was his car. When he replied that it was, they detected the odour of alcohol on his breath. His speech was slurred and his eyes were red and glassy. Combined with the fact that the roads had been clear and dry and the nature of the accident, they formed the opinion that he could be intoxicated.

They asked for a sample of his breath, but he said he did not understand.

At that point, he was taken to Northumberland Hills Hospital, where he was again asked for a breath sample. He refused, claiming a hurt neck and difficulty in breathing.

He was asked for a blood sample from which intoxication levels might be determined, but Grenon grew so agitated that he had to be sedated. Police realized he was in no state to agree to any intoxication tests, so they arranged for access to his medical records and any blood that might be taken that would not be necessary

for medical tests. Grenon was determined to have fractures of the spine and a lacerated liver, and was transferred to Sunnybrook Health Sciences Centre in Toronto. With blood that remained unused for medical purposes, they determined his intoxication level to be between 180 and 220 milligrams of alcohol per 100 millilitres of blood - more than twice the legal limit of

The speed of his car had been at least twice the legal limit, too, officers discovered. Reconstruction of the accident at the scene determined he had been travelling at 162 km/h in an 80-km/h zone.

The defence lawyer said he would discuss the deceased

and his relationship to Grenon at a later date. Meanwhile, he asked to delay sentencing until after a final medical

appointment for his client in December, and a pre-sentence report in the meantime.

Kelneck asked for and received a 10-year driving prohibition to take effect immediately. Grenon surrendered his licence on the spot.

The pre-sentence report is to be ready by Nov. 9, at which time a date for sentencing will be set.

CASTLETON — Cramahe Township council has approved the contract to renovate the lower level of the Castleton Town Hall.

The lower level housed the Castleton branch of the Cramahe Library but was closed when the building was undergoing extensive renovations last year. There was some fear in the community that the little-used branch might never reopen.

The \$39,310 renovation job ensures there will be a library in the building in the near future.

Construction by Fisher Construction was to begin by Aug. 13 and be complete within 60 days. After that, the township will move in under the direction of the Cramahe Library Board. Shelves and equipment will be installed.
