Cramahe won't buy prosecutor

CRAMAHE TOWNSHIP Cramahe Township won't be joining other municipalities in Northumberland County that decide to hire a joint prosecutor for bylaw infractions.

A report prepared by township chief administrative officer Christie Alexander stated that costs and time sometimes make enforcement of bylaws difficult. People need to know that the township will prosecute infractions.

The Northumberland CAOs group recommended that a part time county prosecutor be hired with the costs being shared on a

per capita basis. Cramahe would pay \$5,000 of the \$50,000 per year estimated cost.

At this week's meeting of Cramahe Township council, Councillor Pat Westrope expressed her concerns first, stating she did not recall having discussed some of the issues brought forward in the report. If one or two communities dropped out then a few others could be left paying the whole shot. She rued the lack of local control over costs and saw no historical evidence to demonstrate the township's return.

Councillor Ed Van Egmond stayed on the same vein, wondering aloud if the township had incurred big costs in the past.

Deputy Mayor Jim Williams was the sole voting member of council to support the motion, arguing that the township had not prosecuted in the past so it had no revenue.

Mayor Marc Coombs felt that property standards would be better enforced.

Van Egmond suggested that there was no need for the service; most people comply with municipal bylaws.

Councillor Clinton Breau proposed that the township's own lawyer could handle any possible prosecutions but the CAO disagreed, noting that all member, communities could benefit from the expertise of a (county) prosecutor.

Better Internet on the way to Northumberland

Service is part of a \$170-million project in eastern Ontario

NORTHUMBERLAND - Residents and businesses throughout Northumberland County will gain access to the Internet at increased speeds and with greater bandwidth, at a cheaper price, by this fall.

The improved service is part of a \$170 million project undertaken by the Eastern Ontario Wardens Caucus to provide broadband access to 95 per cent of the people living within a 50,000-square kilometre area.

"I'm pleased to say we're on time and we're on budget," Hastings CAO Jim Pine told County council Feb. 15.

"If we want to be competitive for our business community, the education sector or individuals at home, getting connected to the Internet is one of the most important things we can do as a municipal government," Mr. Pine said.

The wardens initiated the project in response to the loss of more than 12,000 jobs in the "traditional economy" -- manufacturing and forestry -- which occurred between 2003 and 2006. Improving access to the Internet using the latest technology was seen as a solution "that would be useful to all sectors of the economy," he said.

The Eastern Ontario Regional Network was established as a non-profit company to man-

age the project and negotiate contracts with Internet service providers.

About 300,000 people living in 13 counties are currently either not connected or "poorly connected."

The Eastern Ontario Wardens Caucus's "mantra" was to narrow the "pricing divide" between rural and urban customers.

"We've been able to bring down the pricing substantially for new customers," Mr. Pine said. "Over a three-year contract, it's going to save people \$2,000."

The federal and provincial governments are each contributing \$55 million to the network's creation, the private sector \$50 million and the wardens caucus \$10 million. Northumberland's share is just under \$600,000.


"By the end of the project we'll have at least 21 separate contracts with companies who will build it and then deliver it going forward," Mr. Pine said.

Bell and Bell Alliant are building the super highway while Internet service providers such as Xplornet Communications Inc. are constructing the "off ramps" through digital subscriber line (telephone), wireless and satellite connections.

Xplomet's wireless network in Northumberland will be made up of 20 towers, nine of them new.

"From an economic development point of view this is the single best project the County has ever undertaken," Councillor Marc Coombs said. "It's going to have a far reaching impact beyond today."
