

OTTAWA -- The man convicted of the murder of a Cobourg Police Service constable will remain in prison.

The Supreme Court of Canada unanimously dismissed the appeal of Troy Davey on Dec. 21. Mr. Davey was convicted of first-degree murder in the 2004 death of Constable Chris Garrett. The Supreme Court of Canada heard the appeal on March 14 and 15. Mr. Davey had argued his conviction should be overturned because the Crown asked local police to vet potential jurors.

Garrett to the former Northumberland Hills Hospital site with a fake 911 call. He slashed the constable's throat, and the officer, as he lay bleeding to death, shot the fleeing murderer with the last of the 17 bullets he fired -- a wound that forced Mr. Davey to seek medical attention and led to his

Mr. Davey was 18 when he lured Const. evaluate the "suitability" of potential jurors, or

whether jurors would be favourable to the Crown. That information was never handed over to the defence.

In its ruling, the Supreme Court said while the Crown had resources available to it that the defence did not, "the appellant had a fair trial and there was no miscarriage of justice."

It also noted canvassing police services for opinions on potential jurors is a conduct that should not be repeated.

The background checks were revealed in a

2009 media investigative series when Ontario's Privacy Commissioner found one in three Crown offices province-wide had engaged in improper jury vetting. The provincial government halted the practice following the report, and amended the Juries Act to protect the privacy of potential jurors. In December 2010, the Ontario Court of Appeal upheld Mr. Davey's conviction, ruling the Cobourg man's trial was not compromised by prose- ≠ cutors seeking advice from police on poten-

Cobourg Police Chief Kai Liu said officers took a moment to remember Const. Garrett, a fallen hero. "We are pleased with the country's highest court unanimous decision to dismiss the appeal of Troy Davey's first-degree murder conviction for the killing of Constable Chris Garrett," said Chief Liu.

A By-Law to Name Certain Roads in the Township of Cramahe

WHEREAS notice of the proposal to pass this by-law must be published three consecutive weeks in Northumberland Today prior to the passing of this by-law, in accordance with the Township of Cramahe's Provision of Notice Policy; AND WHEREAS the Council of the Corporation of the Township of Cramahe will hear all persons who apply to be heard no matter whether in objection to or in support of this by-law;

AND WHEREAS the Council of the Corporation of the Township of Cramahe deems it expedient that the said lands be named;

NOW THEREFORE the Council of the Corporation of the Township of Cramahe proposes to ENACT as follows:

1. That the following lands being described in Column 1 hereby be named as set forth in Column 2:

COLUMN 1

Part of the road allowance between Cramahe Township Concessions 4 and 5

Running west from Northumberland County Road 25 to the western Cramahe Township border with Alnwick/

Haldimand Township. Described as Plan 39R 12657 Parts 1, 2, 3 Being Parts of Lots 32, 33, and 34 Concession 4

And further being described as Plan 39R 12387 Parts 2 and 3 Being part of the road allowance between Concessions 4 and 5 and Part of Lot 33 Concession 4

> This by-law shall come into full force and effect on the date of final passage, January 8, 2013




ACCEPTABLE ITEMS
