Take Notice that the Council of the Corporation of the Township of Cramahe has initiated an amendment to the Official Plan of the Township of Cramahe, as amended, and is notifying the public in accordance with Section 17 of the Planning Act.

And Take Notice that the Council of the Corporation of the Township of Cramahe will hold a public meeting to consider the proposed Official Plan Amendment under the provisions of the Planning Act.

Location of the Subject Lands

The proposed Official Plan Amendment applies to Section 6.2.1.19 of the Official Plan and does not apply to any particular land within the Township of Cramahe. Therefore a key map has not been provided.

Purpose and Effect of the Official Plan Amendment

This Official Plan amendment will revise Section 6.2.1.19 of the Official Plan of the Township of Cramahe to permit the Township to grant-consents (severances) which are currently under an existing Plan of Subdivision.

The proposed amendment does not add or delete a policy in the Official Plan, but will replace Section 6.2.1.19 with a similar policy. The proposed amendment does not change or replace a designation in the Official Plan.

Section 6.2.1.19 currently reads as follows:

"6.2.1.19 Previous Consents and Subdivisions

Severances will not be permitted on lots which have previously been created by consent for a non-farm use, or lands which have been the subject of a registered plan of subdivision."

As replaced by this proposed amendment, the policy under 6.2.1.19 will read as follows: "6.2.1.19 Previous Consents

Severances which create new lots will not be permitted on lots which have previously been created by consent for a non-farm use. Lot boundary adjustments may be permitted in accordance with Section 6.2.1.11 of this Plan."

The purpose and effect of Official Plan amendment No. 12 will be to allow consent (severance) applications on larger lots under an existing Plan of Subdivision to be considered for severance by the Land Division Advisory Committee and Council. Proposed applications for severance would still need to be in compliance with all other planning documents including the policies in the Township Official Plan and applicable provincial plans.

The proposed amendment is consistent with the policy statements issued under subsection 3 (1) of the Planning Act.

Representation

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Cramahe before the proposed Official Plan amendment is adopted, the person or public body is not entitled to appeal the decision of the Ministry of Municipal Affairs and Housing to the Ontario Municipal Board.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Township of Cramahe before the proposed Official Plan amendment is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.


