### Attention Dog Owners!

The Township of Cramahe requires that your dog is licensed every year on or before **March 1<sup>st</sup>**. New dog owners are required to apply for a license **within 10 days** of obtaining a dog. Having a tag on your dog's collar will assist in quickly returning your dog to you when he or she is found.

The **maximum number of dogs** per legal dwelling unit is limited to **three (3)**, otherwise a Kennel License is required. Prior to obtaining a Kennel License, you must confirm the zoning of your property by contacting the By-Law officer at (905)-355-2846 Ext. 126.

**2016 Dog License rates are as follows:**

- Dog Tag \$15.00 (Before March 1<sup>st</sup>)
- Dog Tag \$25.00 (On or after March 1<sup>st</sup>)
- Kennel License \$100.00

### Friendly Reminder

The winter season is upon us and with the weather comes snow. Please see the Township of Cramahe's Bylaw 02-28 concerning this below:

"Parking on any street or highway within the Township of Cramahe is **prohibited** November 1<sup>st</sup> to April 15<sup>th</sup> between the hours of 11 p.m. to 7 a.m. for snow removal." – *Bylaw 02-28 Section 4(A) (9)*

Vehicles parked in contravention of this section will be ticketed and may be removed at the owner's expense.

Please be advised that all parking on King Street (North and South sides – within town) is limited to two (2) hours only. Please see below for reference.
