\$400,000 budget deficit 'way out of line,' Arthur says

CRAMAHE TOWNSHIP — Oops!
Somehow a 2014 budget deficit "was not known" when Cramahe Township Council passed its 2015 budget, a staff report presented to Council Oct. 20 states.

"I am not happy we are \$400,000 over-budget (for 2014) and didn't find out 'til October (2015)," Deputy Mayor Sandra Arthur said at Tuesday's meeting. "We need procedures in place. We're way out of line."

"I think you're saying we need better checks and balances," Mayor Marc Coombs said.

"Bigtime," Arthur replied. "When I go over the financials, this has got to stop," noting that reviewing of September 2015 financials indi-

cates "We're already over-budget (for 2015)."

So, Council had two options: drain two reserve funds plus draw on a third reserve fund that really isn't for that purpose — or head into 2016 and raise the \$400,000 with a tax increase.

Drawing \$103,709 from the winter maintenance reserve would zero out that fund. Pulling \$139,268 from the

stabilization reserve (set up to offset large tax increases) would exhaust that account. Drawing \$165,681 from the working fund reserve (the only other reserve fund with available funds) would leave \$531,941 in that account.

The 2014 audited statements were presented for approval at the Oct. 6 Council meeting. If Council opts to use the three reserve funds, that offi-

cial audit then requires alterations.

The 2014 budget overruns were from \$280,000 in salaries primarily accrued from unexpected high winter maintenance duties, as well as library and building department cost overruns, the staff report to council states.

Council opted to go for the reserve draw-down option to pay off the 2014 budget overrun.

Building dept. support extended again

cramahe Township. But Council on Tuesday approved extending payment for support staff until the

end of November 2015.

Earlier this year, Cramahe chief building official (CBO) Natalie Moroz-Cornell, citing a heavy workload and unfinalized building permits, requested full-time assistance. Council rejected the request but budgeted \$20,000 to hire help "as needed." A retired CBO and a college student were brought in — and the \$20,000 has been exceeded.

On Oct. 6 Cramalie Council approved the part-time CBO until the end of October, but would not approve extending payment until the end of the year and asked for a more detailed report of building

department work for the Oct. 20 council meeting.

Presenting three tables of work duties on Oct. 20, Moroz-Cornell once again lobbied for more staff. One table indicated eight outstanding building permits have now been closed: Big Apple, Hoselton, Cam Tran, To-

bacco Road landfill, Cramahe Foods, Real Flex, Smith Road settlement and Brighton Cramahe border walking trail. Five remain on hold: King Street East apartments, Storrack, 911 system range errors, road name bylaw and Cramahe Community Gardens.
