Passed Red Cross course one day and saved a man's life the next



BELLEVILLE - One day after completing a Red Cross lifesaving course, Patricia Ashby of Castleton used that training to save a life.

Elmer Ward, 73, of Warrensville, Ohio, had suffered a heart attack in August, 1976, while fishing on Sharbot Lake and Mrs. Ashby successfully revived him.

She was presented with the St. John Ambulance Association award on the weekend by Deputy - commissioner K. W. Grice of the Ontario Provincial Police.

"We'd spent the summer doing this Red Cross swimming program," she said after the ceremony at Ontario Provincial Police District 9 headquarters here. "It was quite coincidental."

Mrs. Ashby had enrolled with sons, Stephen and Andrew, now 11 and 6, and daughter, Lynn, now 9. That day, the family was visiting her parents, Ernest and Isabel Evernden, at their Sharbot Lake home.

Mrs. Ashby was preparing a cup of tea for her parents. "We'd just arrived a few minutes before," said Mrs. Ashby. "We heard a dog barking and the kids said someone down below on the water was in trouble."

The 'trouble' was a fire on board a small craft. Mr. Ward and Larry Pringle, 15, of Garfield Heights, Ohio, had been fishing and the outboard motor caught fire. Unable to extinguish the flames, the two fishermen jumped into the water and Mr. Ward subsequently had a heart attack.

Larry Pringle managed to pull his unconscious partner the 75 to 100 feet from the boat to the shore, where Mrs. Ashby helped pull the heart attack victim out of the water onto a

dock. She immediately applied mouth - to - mouth resuscitation, reviving Mr. Ward. He was taken to Perth Hospital where he recovered.

Mrs. Ashby never heard from the man again and has never been called upon to practice her training. "It happened so quickly," she said. "You really don't have time to think."

Her husband, Noel, who attended the ceremonies, was in northern Manitoba at the time. He hasn't taken a lifesaving program.

Mrs. Ashby's award reads: "Patricia Ashby, who by means of a practical knowledge of first aid, successfully administered mouth - to - mouth resuscitation to a 73 - year old man who had been pulled from Sharbot Lake, Ontario, on 20 August, 1976."

Castleton, where the Ashbys reside, is north of Colborne.
