A Letter to the Editor

about 1907 1970.

Dear Sir:

In last week's issue of the Times, tje Rev. Murray Brooks, a former Port Elgiboy, critized Mrs. Anna Meyer's promotion of the Bruce County Tartan.

I am also a resident of Port Elgin, and it was at a Bruce Centre Institute concert I made mention that Bruce have a Tartan as a Centennial program.

All four Institute branches were enthusiastic over the project and appointed committee of five: Mrs. Rowe of Kincardine, Mrs. Jacklin of Brant Township, Mrs. Hepburn of Hope Bay, Mrs. Gateman of Southampton, secretary, and myself as chairman.

Following extensive inquiries it was learned that a direct application to the Lord Lyon, King at Arms, in Edinburgh, Scotland. He refused to deal with the committee, and stated that the county was the only one to be considered.

Before permission was granted, the county had to have a new coat-of-arms and pay for the registration, and on June 27, 1964, Bruce County had a Tartan.

The Tartan committee financed the first run of the Tartan, and later County Council financed the Tartan program. This year council decided to turn the sale of the Tartan to a private individual and Mrs. Meyer was granted the rights for the manufacture and sale of the Tartan.

Five per cent of the sale of the Tartan clothing will be given to the Bruce county Children's Aid, and the 95percent for the merchandising of the clothing.

During the six years of the Bruce County Tartan there have been many highlights and many disappointments. Through it all, the weekly press has been good to upon most occasions. Radio and Tv have been very generous with publicity, and sale

speaking for all of the committee, we wish Mrs. Meyer great success in her promotion of a very good publicity program for Bruce County.
