OUR OTTAWA LETTER.

Trouble Among the Liberals in Montreal. The Local House. The Conservative Timber Policy. The Coming Session of the Dominion Parliament.

Ottawa, Dec. 14.—The center of political gravity has shifted from the Parliament to the commercial metropolis. Down in Montreal there is trouble of a somewhat serious nature in the Liberal camp. We hear that an alliance between Sir Wilfrid Laurier, Sir Adolphe Chapleau and Hon. Isidore Taylor is on the tapis.

It is stated in this correspondence that Sir Adolphe is a particularly strong man in Quebec. The settlement of the Manitoba school case is not considered satisfactory by the Liberal Administration at Winnipeg, and it is not looked upon with favor by the Laurier Government.

The plan is to propose an amendment in the Budget Bill, which Sir Adolphe is to give his aid. Mr. Francis Langille has long been an aspirant for the Lieutenant-Governorship of Quebec; in fact, he went so far a few weeks ago, as to state that Sir Wilfrid had promised him the post.

But Sir Wilfrid also seeks the place, which is worth ten thousand dollars a year. The proposition is that a commission shall be formed to enquire into the whole affair, and that Sir Adolphe shall give the Government his aid in arriving at a settlement. The Ontario Liberals see no reason why the question should be reopened, and, consequently, they are disposed to side with Mr. Langille.

It is not clear how the issue will be settled, but it is believed that the Government will be forced to give Sir Adolphe the post. This is a serious matter, as it would mean the end of the Liberal party in Quebec.

VICTORIA TO THE YUKON.

Postmaster-General Makes Provision for Carrying Mails. The Montreal Police Force in the Yukon to Be Reconstituted. A New Money Order System for Canada—Postal Notes to Replace Postoffice Orders—It is Expected Commissioner Foster's First Office to Be Sir Wilfrid Laurier.

Ottawa, Dec. 20.—Postmaster-General Mulock has authorized the dispatch of a mail from Victoria to the several places on the Yukon route, including Dawson, Wrangell, and Lakh. The route is to be carried by the Yukon Navigation Company, which is to be reconstituted.

It has been decided to increase the force of police in the Yukon from 90, to 100, which will be stationed at Dawson. The balance will be stationed at Selkirk, Fairbank, Delta, Fair, the Skeena, and other points on the territory.

NEW MONEY ORDER SYSTEM. Canada will adopt the postal note system in the Yukon Territory. The postal notes will be issued in denominations of \$1, \$5, \$10, \$20, \$50, and \$100.
