

NATIVES REMAIN LOYAL.
REV. J. MOFFATT, MISSIONARY,
DISCUSSES THE SUBJECT.
South African Natives Are Loyal to British, Who Helped Them to a Man and Broke for Him the Chains of Slavery.
Rev. J. S. Moffatt, the well known African missionary, in a letter to the London Daily Mail, speaks of the natives of South Africa, who say that they are loyal, though some of them who lived among the Boers to save themselves, their families and possessions, may have seemed to side with the Boers.
"There is a strain of faithful loyalty in the Bantu character which is not to be surpassed," says the missionary.
"It is a fact as big as Table Mountain, that the vast majority of the colored and the colored races are of the British side in sentiment during the struggle which has been going on for a year and a half. By the colored races I mean the mixed people in the colonies and sometimes Republics, including with full-blooded Hottentots and the imported aborigines up to the almost white, whose fathers, whatever their motives may have been, were Dutch or English."
Mr. Moffatt points out that the natives remember that the British broke the chains of slavery; that the natives have reduced them to the lower stratum of human existence; that the British have given high wages in Johannesburg and many other proofs of friendship.
ZULUS PRAEFUL.
"In Natal and Zululand; with a population of Bantu outnumbering the white people by ten to one," says the missionary, "our Zulus have said they might have been seen peacefully driving their ploughs within range of the guns round Ladysmith."
"The Boshwana tribes all along the western border of the Transvaal have been loyal to us, though many of them suffered the loss of their stock, which we could not defend for them. Further north a message was sent to the well known chief Khama; we did not want to interfere with you, we want to come and root out the evil from your country." The assurance we will speak to you with our millions of men, have helped us, taking part in the conflict, and allowing them to do so, we have quiet in obedience to us."
