

By-Law No. 216

A BY-LAW TO RAISE THE SUM OF FIVE THOUSAND DOLLARS FOR THE PURPOSE OF ERECTING A CONTINUATION SCHOOL IN THE VILLAGE OF MARKDALE IN THE COUNTY OF GREY AND TO AUTHORIZE THE ISSUE OF DEBENTURES THEREFOR.

Whereas the Board of Trustees of the Markdale Urban Continuation School District have applied to the Municipal Council of the Village of Markdale for the sum of five thousand dollars for the purpose of purchasing a site in the said Village of Markdale and erecting thereon a building to be used as a Continuation School and equipping said school building as the Board may deem efficient.

And Whereas the Municipal Council of the said Village of Markdale deem it advisable to pass this By-law for the purpose of raising the said sum of Five Thousand Dollars and interest for the above mentioned purposes.

And Whereas in order thereto it will be necessary to issue debentures of the said Municipality for the sum of Five Thousand Dollars as hereinbefore provided (which is the amount of debt intended to be created by this By-law) the proceeds of said debentures to be applied to the purposes aforesaid and to no other.

And Whereas it is desirable to issue the said debentures at one time and to make the principal of the said debt repayable by yearly sums during the period of twenty-five years, being the currency of the said debentures; said yearly sums being of such respective amounts that the aggregate amount payable in each year for principal and interest in respect of said debt shall be as nearly as possible equal to the amount so payable in each of the other twenty-four years of said period (as shown in Schedule "A" hereto annexed.)

And Whereas the total amount required by the "Municipal Act" to be raised annually by special rate for paying the said debt and interest as hereinbefore provided is \$354.76.

And Whereas the whole rateable property of the Village of Markdale, according to the last revised Assessment Roll is \$13,563.00.

And Whereas the amount of the existing debenture debt of the said Municipality is \$41,233.78, of which no part of principal and interest is in arrear.

Therefore, the Municipal Council of the Corporation of the Village of Markdale enacts as follows:

1. The Municipal Council of the Corporation of the said Village of Markdale shall hand over to the said Markdale Urban Continuation School Board the sum of Five Thousand Dollars to be expended by the said Markdale Urban Continuation School Board in the manner aforesaid, and for the purpose of raising the said sum, debentures of the said Village to the amount of Five Thousand Dollars as aforesaid in sums of not less than \$100 each shall be issued on the First day of June, 1910, each of which debentures shall be dated on the date of issue thereof and shall be payable within twenty-five years thereafter, namely, on the Fifteenth day of December, 1934, at the Treasurer's office in the said Village of Markdale.

2. Each of said debentures shall be signed by the Reeve and the Treasurer of the said Village of Markdale or by some other person or persons authorized by By-Law to sign same, and the Clerk shall attach thereto the corporate seal of the Municipality.

3. The said debentures shall bear interest at the rate of Five per centum per annum payable yearly at the said Treasurer's office on the Fifteenth day of December in each and every year during the currency thereof, and shall have attached to them coupons for payment of said interest which coupons shall be signed by the Reeve and the Treasurer of the said Village of Markdale.

4. During the currency of the said debentures there shall be raised annually by special rate on all the rateable property in the said Village of Markdale the sum of \$354.76 for the purpose of paying the amount due in each of the said years for principal and interest in respect of the said debt, as shown in schedule "A" hereto annexed.

5. This By-law shall take effect on the day of the passing thereof.

6. The votes of the electors of the said Village of Markdale shall be taken on this By-law at the following times and places, on Monday, the Twenty-eighth day of March, A.D. 1910, commencing at the hour of 9 o'clock in the forenoon and continuing until Five o'clock in the afternoon of the said day by the following Deputy Returning Officer, Robert J. McKeenmitt, and John H. Dundas, J. Poll

Clerk, in the Council Chamber, Haskett's Hall.

7. On Monday, the Twenty-first day of March, A.D. 1910, the Reeve of the said Village of Markdale shall attend at the Council Chamber at Two o'clock in the afternoon to appoint persons to attend at the polling place aforesaid and at the final summing up of the votes by the Clerk on behalf of the persons interested in and promoting or opposing the passing of this By-law respectively.

8. The Clerk of the Council of the said Village of Markdale shall attend at his office in the Town Hall at Ten o'clock in the forenoon on Wednesday, the Thirtieth day of March, A.D. 1910, to sign up the number of votes for and against the By-law.

SAVED TRAIN FROM WRECK

Farmer Near Owen Sound Flags Train in Nick of Time.

The presence of mind of John I. Brown, a farmer in the township of Sydenham living only two miles from Owen Sound, prevented a serious railway accident. On Saturday afternoon with his son, Mr. Brown was returning from town and was walking on the C. P. R. tracks near the Superior street crossing when he noticed a broken rail. Living as he does near the track, he remembered that the north bound freight was nearly due, and he at once realized the immediate danger. He sent his son to a nearby house for something to flag the train. At the same time he himself ran up the track in the direction in which the train was expected. Not a minute too soon did he act, for almost immediately engine 1745, one of the big type freight engines, came in sight. Engineer Patterson, seeing the signal, at once brought the engine to a standstill. A caboose was attached to the engine and the conductor at once sent a signal back to the way freight, which was following close in the rear. Had it not been for Mr. Brown's prompt action possibly both engines and the way freight would have been wrecked.
