

In the Provinces to Aid of Agriculture

been placed, chiefly in the newer districts. The work of farming associations and supplying stock during this year is still active.

For next year the Live Stock Department has carefully prepared its plans, and the amount of stock distributed will be greatly increased. Beginning early in March, at least 200 pure-bred stallions will be placed in charge of associations formed or which will be formed this winter. There will also be placed at the disposal of the association 300 pure-bred bulls and 500 each of sheep and swine. All the associations have to do is provide for the keep of the stock. The Government is providing and paying cost of distribution. The marked success of the policy this year has led the Government to greatly increase the expenditure in this direction.
