

Zealand has claimed the premier position in the matter of Cheese. Will Canada permit such to continue?

Canada was so unfortunate as to have little or no cheese on the market last winter, when New Zealand cheese was fetching as high as 145 shillings per cwt. of 112 lbs., compared with the present price of 108 to 112 shillings. Still, even this present average price of 110 shillings compares very favorably with the price ruling at the corresponding period of last year, namely 84 to 90 shillings.

It will be interesting to see if, as a result of the predominance of Canadian cheese on the market during the next few months, the difference in the price of Canadian and New Zealand cheese will be wiped out permanently. As previously pointed out, New Zealand has been fetching from 2 to 4 shillings a cwt. more than Canadian during the past few months. This is all the more regrettable, because it used to be the other way about.

During the first six months of the present year, Canada sent only 108,672 cwt. of cheese to the United Kingdom, a reduction of 29,950 cwt. compared with the corresponding period of last year.

### Department of Agriculture

Premium Policy For Rams  
Once again the season when Rams will be required is fast approaching. Undoubtedly many will be forced to purchase a male. To them the announcement of the continuance for another year of the Premium Policy should be favorably received.

Briefly it is as follows:—Any farmer never having owned a registered ram, of any breed, and having over 10 ewes, can secure a premium of \$10.00, payable \$5.00 this year and \$5.00 next year, provided he purchases a Ram which will register, and makes application to the Department of Agriculture, Markdale, before December 31st. of the year the ram is purchased.

Such action is ruinous to the Sheep Industry and destroys the market for lambs. Why not take advantage of the Premium Policy, buy a pure bred and improve your stock?

On two or three occasions this past month, on trips through the County, it has been intimated that farmers say they will not receive the Premium for Rams, even if they apply. Even prominent breeders say they cannot alay the suspicion which exists in the farmers' minds. Some feel the Premium Policy is some "catch" which will involve them in a trip from which there is no escaping.

To the farmers, who are suspicious, let it be known that over 200 farmers in Grey County have already applied for and received the Premium or part of it. The last payment will be made during the winter. Not one of them has become tripped and will not. If you are entitled to the Premium, kindly write before December 31st. to the Department of Agriculture, Markdale. We are here to serve you. There is no charge for anything we do.
