## Live Stock Market Report

Almost 5000 cattle arrived for Tuesday's market, and with a good demand for practically all classes of cattle, prices held steady. Export buyers were active in securing their requirements for shipment to the Old Country, while packers buyers took care of a large number of good butchers and heavy steers. At the close there was about 1000 cattle unsold.

Choice heavy steers brought from 5.50 to 6.00; fair to good from 5.00 to 5.40; common and medium 4.25 to 4.75. Choice butcher steers and heifers brought from 5.00 to 5.40; fair to good 4.50 to 4.90; common and medium 3.75 to 4.25. Baby heaves were in strong demand, choice from 6.75 to 7.50, others lower according to quality. There was a good enquiry for stockers and feeders. Selected light weights from 3.25 to 3.65 and feeders from 3.50 to 4.00. Common stockers ranged from 2.50 to 2.75. Choice fat cows sold at from 3.00 to 3.25; fair to good from 2.50 to 2.90; common and medium 1.75 to 2.40; canners and cutters 1.00 to 1.75. The bull trade held steady, choice from 3.00 to 3.25; common 2.50 to 2.75.

Supplies of lambs were in keeping with the present demand and the market held steady. A limited number of car-load lambs made 8.25, with truck deliveries 8.00 for choice ewes and bucks at 7.00. Choice butcher sheep sold at 3.50, others at lower prices according to quality. The calf trade was active and strong, choice from 8.00 to 8.50; fair to good from 7.00 to 7.75; common and medium 5.50 to 6.50; grass calves 3.25.

Hog supplies were very heavy at all centres and prices worked lower. Truck deliveries selling at 9.15. It will depend entirely upon supplies

during the balance of the week, as to what takes place, if the runs continue heavy, prices will likely work lower.

## HOLLAND TOWNSHIP COUNCIL MINUTES

Holland, September 1, 1936

Council met on Tuesday, September 1st, for the transaction of Township business, all the members present, John Heighes, Esq., presiding.

The minutes of the last meeting were read and confirmed. The following were then read: Resignation of Dr. Rabb as M. O. H.; communication from F. H. Rutherford, enclosing order of Judge Morley relative to appeals against the county equalization; report of Chris. Routenburg, sheep valuer, valuing one sheep belonging to Wellington Beirnes, \$6.75; report of M. J. Farrelly, valuing sheep belonging to Emerson Craven, \$8.00, and one belonging to Thos. Moore, \$7.00; several accounts for relief, \$20.73; report of G. J. McNeely, valuing sheep of John Hamilton, \$16.00.

Dixon - Sutcliffe—That this council accept the resignation of Dr. Rabb as M. O. H.—Carried.

Howey - Dixon—That the Reeve represent this Township at the Court of Appeal re County Equalization at Owen Sound on Friday, September 4th.—Carried.

Gillespie - Dixon—That we pay \$443.50 to Howard Weaver, balance on bridge contract.—Carried.

Howey - Sutcliffe—That leave be granted to introduce a By-Law to strike the necessary rates in the Township for the current year.—Carried.

Leave granted, By-Law introduced and numbered 23. Sutcliffe - Dixon—That By-Law No. 23 be now read the second time.—Carried.

By-Law No. 23 was read a second time accordingly. Gillespie - Sutcliffe—That By-Law No. 23 be now read a third time, signed by the Reeve and Clerk, and engrossed in the By-Law book.—Carried.

By-Law No. 23 was then read and signed accordingly. Dixon - Gillespie—That leave be granted to introduce a By-Law to appoint a M. O. H. for the Township of Holland.—Carried.

Leave granted, By-Law introduced, read a first time and numbered 24. Howey - Sutcliffe—That By-Law No. 24 be now read a second time.—Carried.

By-Law No. 24 was read accordingly. Gillespie - Howey—That the name of Dr. I. B. Thompson be inserted in the By-Law and that it be now read a third time, signed by the Reeve and Clerk, and engrossed in the By-Law book.—Cd.

By-Law No. 24 was then read and signed accordingly. Gillespie - Sutcliffe—That Robert Ceaser be re-engaged as Tax Collector for the Township of Holland for the year 1936 at a salary of \$150 per annum, duties to commence by the first of October.—Cd.

Howey - Sutcliffe—That the following notice be inserted on tax notices: All taxes are now due but may be paid in two instalments as follows: All Hydro and Telephone rates to be paid on or before 2 o'clock p.m., December 15th, 1936, and one-half the balance. The second instalment to be paid on or before March 15th, 1937. A discount of one per cent. will be allowed on the second instalment if paid on or before December 15th, 1936. The following penalties will be imposed and collected on unpaid taxes of first instalment: If not paid by December 15th, 1936, but paid on or before January 15th, 1937, one per cent.; if paid between January 15th and February 15th, two per cent.; if paid between February 15th and March 15th, three per cent., and on all taxes unpaid by March 15th a penalty of four per cent.—Carried.

Howey - Sutcliffe—That the Road Superintendent's pay sheet No. 7, for the sum of \$1734.02, be paid and the Treasurer issue cheques for the same.—Carried.

Dixon - Howey—That this Council permit the Chairman of Game and Fisheries to build a bridge at William's Lake, Con. 2, W.T. & S.R., providing they be responsible for all damages done to either private property or the Highway.—Carried.

Mr. Howey presented Report No. 9 of the Finance Committee, recommending payment of \$174.38.

Gillespie - Dixon—That Report No. 9 of Finance Committee be adopted as read.—Carried.

Council then adjourned until Tuesday, October 6th, at one o'clock p.m.
