### CONFERENCES WITH CABINET MINISTERS

As mentioned in an earlier article, in addition to the conference which we had with Britain's Prime Minister, we had important meetings with a number of the Cabinet Ministers. Naturally as editors we were particularly interested in meeting the Minister of Information, the Hon. Brendan Bracken. Before his appointment to this post in July, 1941, Mr. Bracken was Parliamentary Secretary to Prime Minister Churchill. He has had practical publishing experience, having been editor of "The Banker", chairman of the "Financial News" and managing director of "The Economist". Mr. Bracken is the fourth man to have held the Ministry of Information post since the beginning of the war. Our conference with him was an inspiring one. He told us something about what England is doing, "the people of England," he said, "are working harder than any other people in the world."

## HOW IS HE GOING TO PAY FOR IT?

"It is no answer to the farmer who wants broader markets to offer him instead a new home with a bath-tub," says R. J. Deachman in a five young people took part Sunday afternoon at the home of Mrs. J. Colquhoun, M.P., leader of the C. C. F., for a big Government housing program after the war. There is no putting it. We would all like the Government to build us new homes but the Government cannot afford to give houses away. They are just as insistent upon payment for their goods and services as private business concerns—and more so. Any taxpayer can tell you that.

Mr. Colquhoun is, of course, assuming that the farmer will have sufficient income to keep up the payments on his new house. There is no doubt that the boom is on, but what about afterwards? The Government cannot go on building houses without lowering the purchasing power of the national income. Mr. Colquhoun wants to know how the Government is to build houses where farm income is too low to meet current expenditures? He says a higher income, and adds: "Apparently Mr. Colquhoun sees no means of increasing income except through the expenditure of public money provided by taxation."
