

STREET LAMPS.

At the meeting of the council on Monday evening last, the subject of placing lamps on the main streets of the village was presented and favorably discussed by the members of the council. This is a subject of special interest to the citizens and we are sure that if the project is carried out it will be welcomed by all. This would require about twelve lamps, and the cost would be nominal compared with the usefulness and comfort afforded. Of course they would require to be lighted only on dark nights and this could be accomplished with very little expenditure.
