Protecting The Brakemen.

The Grand Trunk Railway management, acting on the recommendation of a recent engineer's jury, and also influenced by a number of men who protect the lives of the brakemen in their employ, are taking steps to place rolling on the tops of the cars. In order that the opinion of the men may be obtained in the matter, Mr. Spier has submitted the plan to the men for their approval.
