A ROUSING MEETING.

The Town Hall filled to overflowing by an Androlic Assembly to hear Rev. Youmans, at the Close of Which Address They Say

THE ACT WILL NOT BE REPEALED.

One of the largest audiences ever seen in the town hall assembled there last Wednesday evening to hear the address of Mrs. L. Youmans, upon the repeal of the Scott Act.

Rev. Fife called the meeting to order, and Mr. D. Henderson, Banker, was moved to the chair.

Rev. R. B. Cook then led in prayer and Rev. J. W. Rae read a passage of scripture, Isaiah 41:1-20.

Resolved: Mrs. Youmans there were on the platform Rev. A. E. Russ, M.A., President of the Temperance Association; Rev. C. R. McCreary, County Organizer for the Association; W. H. Young, Esq., Police Magistrate; Rev. R. Phillips, Rev. J. W. Rae, and Rev. R. B. Cook.

After referring to his personal curiosity to hear a lady speaker the chairman very briefly introduced Mrs. Youmans the speaker of the evening.

The talented lecturer spoke ably, pointedly and effectively for over an hour, depicting the horrible results of the licensed whisky traffic in unmistakable colors.

She dwelt upon the principle that "ye shall know the truth and the truth shall make you free," and with her there was no withholding of the truth concerning the evils of intemperance in its many and varied forms.

THE PROVINCIAL CONFERENCE.

Summary of the Resolutions Passed by the Conference of Premiers at Quebec.

No. 1 proposes an amendment to the British North American Act to remove the power of disallowance now vested in the Federal authority, so as to leave those matters on which the Provinces have exclusive jurisdiction subject only to disallowance by the Queen in Council as before.

No. 2 proposes the establishment of a tribunal to decide the constitutionality of statutes, both Federal and Provincial, before, as well as after, such statute has been acted upon.

No. 3 would provide that private litigation shall not call in question the validity of any statute after two years from its passage. After that time it should be challenged only by a government, and any previous decision should have full force as if such statute had been constitutionally enacted.

No. 4 would amend the Confederation Act so as to limit the term of all Senators. It also proposes that as vacancies occur in the Senate, the new Senators should be chosen by the Province to which such vacancies belong, until one half the Province's quota has been filled by such selection. The other half to be appointed as at present, and this proportion to be maintained.

No. 5 would amend the Act so as to secure the independence of Lieutenant-Governors from Federal interference and giving them the same status as Governors of other colonies or provinces.

No. 6 would forbid the assumption of Provincial public works by the Federal power on the plea of their being for the general advantage of Canada, except where such general utility has been declared in the Acts creating them.

No. 7 provides for the districts and electors for the members of the House of Commons, being not those provided by Provincial legislatures for the Provincial Legislatures. No. 8 requires the amendment of the N. A. Act so as to affirm the Provincial jurisdiction to appoint Stipendiary Police, and other Magistrates.

No. 9 desires amendment, giving all fees from legal proceedings in Provincial Courts to the Provincial treasuries.

DYNAMITE ARGUMENT.

The Orangeville Whiskey Anarchist Party made their Sixth Heinous Outrage.

ASQUITH ACT INSPECTOR THE VICTIM.

Orangeville, Nov. 15. At half-past eight o'clock this evening the house of Scott, Act Inspector Anderson, on Second avenue, was again blown up by dynamite. The charge was placed on the verandah at the front of the house and the two front windows in the dining room were badly shattered. Mrs. Anderson, who was alone in the house, was badly injured. Her screams could be heard several blocks away. The inspector and his wife were only about ten yards away when the explosion occurred. He was stunned by the concussion. A note was found tacked to the fence, warning him to desist from his efforts in favor of the Scott Act, and stating that he might congratulate himself that he had not been blown to "kingdom come" before this. Several Orangeville hotelkeepers have been fined for violating the Scott Act during the past week, and it is a notable coincidence that dynamite explosions always occur after the liquor men have been fined for breaking the law. The statement proved for the town. This is the sixth dynamite explosion that has occurred in Orangeville in two years.

THE CENTRAL BANK SUSPENDS.

And Temporarily Closes its Doors. The Bill Likely to be Retained.

Toronto, Nov. 16. The Central Bank will not open its doors for business this morning. The directors decided last night to temporarily suspend. The announcement of the directors is as follows:—

"Toronto, Nov. 15. In consequence of the present money stringency the Central Bank has not been able to realize on its assets promptly as it has therefore, for the present, suspended payment. By order of the Board."
