#### EDITORIAL NOTES

In last week's issue of the Bowmanville Statesman the roll is called 'of men who have made their mark in agriculture, in Durham, and an appeal is made to the young farmers of the county to prepare themselves for like achievements in future.'

The support of Canadian over the Anglo-American route was demonstrated when a letter posted in London on the 8th, coming by the Canadian route was delivered in Montreal seven days later, while our coming via the American route took eleven days for the journey.

The public debt of Canada was \$2,000,000 less at the end of September, end of first half of present fiscal year, than it was at the end of March, 1908, end of last fiscal year. Interest charges are only slightly increased since last year, while the per capita interest on the public debt is less than it was in 1908. Total revenue for six months is \$1,229,297 greater than for same period last year. Canada is certainly going home.

It looks as if Halton County is about to have Local Option in every municipality except the town of Milton. Contests are to take place next January in Acton, Georgetown, Esquerring, Oakville and Nelson, with very bright prospects of success in every one of these places. The bars have already been banished from Nassagawey and Trafalgar townships. Erin and Clinton, adjoining townships, are under Local Option and Erasoma expects to carry it at the coming elections. Brantford is also engaged in a campaign.

Referring to the proposed application of the maximum American duties to Canadian goods, the New York Journal of Commerce advised the Washington Government that the amount of Canadian tariff duty on United States trade is greater than the capacity of the United States to inflict injury on Canadian trade. This is obvious from the fact that the Dominion now spends two dollars in the Republic for every dollar which the Americans spend here. Moreover, Canada possesses raw materials of which United States manufacturing industries stand much in need.
