## INTERESTING LETTER FROM THE SOUTH

**Dr. T. D. J. Palmer Writes from His Winter Quarters at New Orleans— Appreciates Canadian Law**

To the Editor:  
The "Year Past": With roses and numerous other flowers flourishing in plenty on the lawn and in the garden, and the local oranges on the streets at fifteen cents a dozen, one certainly feels that New Orleans, although not in the extreme south, is a pleasant change from our northern conditions, at this time of the year.

When I arrived here late in November, the local press seemed much concerned over the same problem that has recently been disturbing the Toronto people, viz: the non-compliance of the Community Chest, and were making frantic appeals to get this filled. The same difficulty had arisen when I was here two years ago, and I had discussed with some prominent citizens on that occasion as to what seemed to be the main reason for the poor response. It was generally apparently worthy object awakened in New Orleans residents. Quite a large percentage of the fund had been directed to pay an expensive organization for its collection and for its distribution. A manager and assistant manager were by-the-way from the north) were drawing immense salaries, a score or more every winter of their valuable time for out the year, and there were heavy rentals and other incidental outlays involved. The majority of those who seemed of the opinion that this was the chief cause for such a like-warm response. Most of them, however, felt that their contributions go wholly and directly to the object of the fund.

They do not like the thought of an army of able-bodied outsiders (professional or otherwise) making a fat living out of large percentage of their often hard-earned donations. And the impartial observer must surely conclude that these objections are in a great measure right. In both the cases of New Orleans and Toronto, and in all large-centres adopting this modern plan, the money contributions deposited directly in some reliable bank and paid out to the different charities on the order of, and in the different amounts fixed by a representative committee of the best business men of the place, all these heavy deductions could be saved. No doubt this committee would be glad to give a few hours every winter of their valuable time for properly determine the share for each charitable body or institution, and how and when it should be distributed. The banks, too, should be glad to handle the fund, free of cost, in such a worthy cause. Every one would be glad to help in its proper collection without any diversion to these highly paid organizers.

The response would be more generous, and those who should be earning their livelihoods in some less ignominious calling than that of a fund-raiser, would be made to the poor and afflicted. There would be no need of a fund-raiser to seek elsewhere for their means of sustenance. One hears complaints here, too, of unfair distribution of the fund, and also that the individual soliciting of funds outside of the fund, is not appreciably lessened.

Stretching for miles near where I am stopping, in almost every direction, are the huge, once aristocratic, but now abandoned frame mansions of New Orleans' leading citizens. With their great double and often triple door-ways, iron railings in front and many of them no doubt containing almost acres of floor space, one wonders how long these stylish old homes have been built. Some of them are over fifty feet wide and a couple of hundred feet long, and many stand quite unevenly and stretch back in a zigzag direction from the street. These rows of old mansions are no doubt of anti-bellum origin, when countless slaves were on hand to do their master's bidding, and when for no servants could be found to-day to undertake the exhaustive work of keeping these in order. The old mansions are aristocratic, or what is left of these, have all moved away to more modern quarters and mansions. These gaunt reminders of former aristocracy, which have been converted into apartments and cheap boarding houses, or become the homes of Jewish and Italian traders. But, while I am touching on the subject of the old mansions, I cannot help but mention that of a colored servant, who does not seem to desire any change.

This community has been greatly stirred recently over the two men involved in the case of the "Pleasant Harris" connected. In the case of Pleasant Harris, a common law wife of the latter, who had been convicted and sentenced to death, the other jury immediately acquitted the woman, although the circumstances in both cases were very much alike.
