Supreme Court Sits This Week Faces 30 Cases

The Honourable Mr. Justice Judson of the Supreme Court in Toronto, is sitting this week before about 30 cases in Halton County's annual fall assizes general sessions at the Court House, Milton.

Included in the heavy agenda are 10 divorce cases, four criminal cases requiring juries, some civil cases with juries, and a few other civil non-jury hearings.

The criminal cases include one charge of attempted murder, one of rape, and two of criminal negligence resulting in death. The civil actions include damages from motor accidents, one estate proceeding, wage disputes, land encroachments and contracts.

Of the divorces, 18 are undisputed cases and one is disputed as to custody.

LETTER TO THE EDITOR

Writer Perturbed About Council Action on Industry

Dear Mr. Dills:

If you will kindly publish this letter, it will address it not only to you but to all the citizens of Acton and the town council.

The reason for this letter is to let you know how shocked I was at the reverse decision of council on the new poultry industry. I can visualize Acton council making a decision on giving a new industry the green light to purchase a building and some new equipment and then change their mind at the last moment.

Now some people might say I am a poor one to criticize when I have never attended a council meeting. But I would like to let them know I follow council news every week in the Acton Free Press and the Guelph Mercury.

I think council is very short sighted in their decision and have set Acton back 10 years in attracting new industry to Acton. Can council think far enough ahead to realize that any new industry thinking about Acton will take a second thought on the word of Acton council. Or can council visualize that the new steel plant that is supposed to be coming can still back out because they may be afraid of council's promise to them.

Now some people might say they won't back out if they have bought land here and have spent a great deal of money developing it. But I maintain that they could sell the land as a farm and only lose a few thousand dollars which would be better than a possible \$100 thousand dollars if they built a factory.

With all this decision going on about industry it brings back memories of about a year ago when councillors Cook and Lowe were griping about no industry in Acton and now they want to cheer them away.

Everybody knows Mr. Cook and Mr. Lowe. You know these fellows who belonged to the infamous ratepayers association. What are we going to get on Acton council? I grade Acton by the fact and guess that a couple of swells those fellows who gave us the impression of a clean, yet impossible watch on.

Come on Mr. Lowe and Mr. Cook give the excuse why we keep in Acton. Let's take all the money we bring in and give new industry in Acton more money, a wider demand on labour and in turn more higher wages, more spending money, more buying power in stores, better products at lower prices, more demand in stores means more competitive

wages, more stores higher assessment, higher assessment LOWER TAXES, which is better for all. Come on give the working man a break.

Mr. Lowe and Mr. Cook seem to think you can't choose about industry and not have to supply industrial power. This is not so. We must grow with the times. In the future we must supply industrial sewers to hold our present and future which surrounding communities like Toronto, Hamilton, Guelph, etc. build size now and not in ten years when the cost will be more. Build when Beaconsfield and the new industry will pay the expense. (Guelph Mercury, J. McGraw, annual \$25,000 revenue Beaconsfield \$100,000 in industry \$22,000.)

Now Mr. Cook seems worried about the possible move until he builds a disposal plant which will create jobs for Acton workers. Did the Acton workers worry when it took time or ten miles to put free services into Glenbow subdivision? Mr. Cook and Mr. Lowe could have a low down payment house which did not create a higher wage for the worker in Acton.

Mr. Cook also seems to think we are subduing industry if we build the disposal plant across the border. But what about the taxpayers who subsidized a credit plant at Malton where we work millions of dollars before they turned out one fighter aircraft which maybe now is outdated.

Mr. Lowe also seems to be worried about the stability of Canada Packers and seasonal work in packing houses. Almost every year we read there was a short hauler's erosion when plants were made for a special meeting for November 10th when Mrs. Currie of Canada will be the guest speaker.
