1,500 Pounds Butter Weekly

Produced at Acton Creamery

Acton is the centre of a farm district with mixed farming and stock raising. The Acton Creamery, a modern, well equipped building, was located at the rear of George Howard's barber shop and in 1929 the Halton Cream and Butter Co. purchased the business and moved to a new location where the Simpsons-Sears office is now located. At this time eight employees are employed.

In 1931 a new building was erected on Main Street and was named the Acton Creamery Limited. When the new building was completed, it housed a locker plant and egg grading station as well as equipment for processing cream to butter.

The cream is collected from egg grading station and locker plant has become obsolete. The plant has had this portion removed and installed ice cream making equipment and additional storage space. Recently a fresh fruit and vegetable section was added and at present the business retains butter, eggs, ice cream, fruit and vegetables.

Paunds Weekly
 At the present time the largest production is in butter and an average of 1,500 pounds weekly are shipped from the plant. Eggs average 750 dozen a week.

The owner, Doug Gibson has plans for 1960 and hopes to expand the retail section with the section of display and first to create a more food lines. The creamer trucks call on farms throughout the district picking up cream and eggs daily.

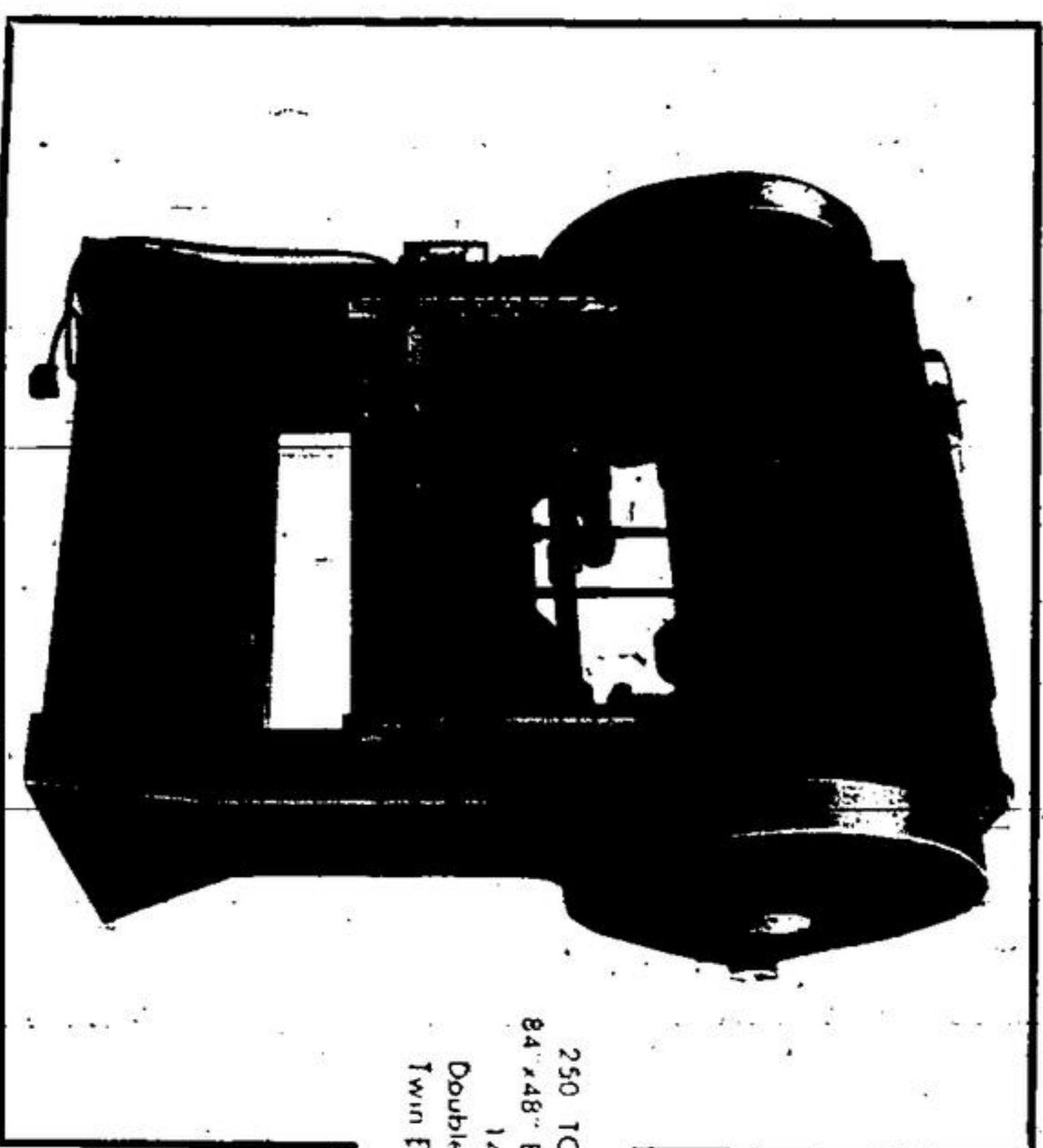
