We must have sound government but we must also keep up with the times. He is in favor of sensible spending, but opposes a rock-bottom budget.




BILL COATS

"We must continue to search



"At the same time Acton must prepare for a population increase. The need for additional dwellings for either ownership or rental is a serious problem in Acton. More land is needed for further residential growth."

"The huilding code should be revised to allow builders to use many of the modern materials and techniques that have been produced by our modern technology. This does not mean a wholesale change in building code but an enlightened amendment to the code based on sound professional advice from all available sources of information."

"Another area of concern is that of the use of our increasing leisure time! The Y.M.C.A. and the Parks and Recreation Committee are currently investigating the recreational facilities in Acton. The council must give active support and encouragement to this work. Our recreational program and facilities should extend to all residents of Acton from the very. young to our senior citizens."

"Next year, for the first time, the home owners in Acton will receive separate tax bills, one from the Town of Acton and one from the newly created Halton Board of Education. Home owners should pay taxes to the town for the benefits that they receive directly from the


