

Halton West M.P.P. George Kerr named Cabinet Minister

For the first time ever, a Halton County member of Provincial Parliament has been numbered a position in the Ontario Cabinet.

George Kerr, the Burlington lawyer who has represented Halton West (formerly Halton) riding since 1963 was appointed Minister of Energy and Resources Thursday by Premier John Roberts.

The move came as a result of the resignation of Minister of Public Works Ray Connell. J. R. Simmonett was removed from his Energy and Resources portfolio to the Public Works position, leaving the Energy and Resources post open to Mr.

Mr. Kerr was born in Montreal, moving to the Gaspe area of Quebec with his parents in the 1930's. After school, he worked with his father in the ...humber business for three years, leaving to add to his education. This included a pre-legal course at the University of New Brunswick, and, later, the Dalhousie law school in Halifax.

At his graduation in 1935, he had been married for two years to fellow-graduate Meredith "Mim" Spicer; He worked as assistant to the county solicitor in Welland briefly.

In 1954 they moved to Burlington, and have since had Larry and James and daughter Margot. Within a year of taking up residence in Burlington, Mr. Kerr was elected to town council, serving for two years.

His first bid for the Burlington deputy-reeve's chair was unsuccessful, but he again tried four years later . . . successfully. It was at that time he left the Hamilton law firm in which he had been employed and started

and involement. He served as chairman of the committee on logal bills and municipal affairs, a committee on consumer credit, and thes legislature's select committee on conservation.

Other causes he has supported include dairy farmers opposition to the Milk Marketting Board's pooling arrangement, attacks on organized crime, changes in Canada's abortion laws, governmental study of automobile insurance costs, and compensation for persons injured while trying to prevent

He has suggested a rebate to the builder or home owner, of provincial sales tax upon completion of a home; and critiscized federal ministers of justice for lack of enthusiasm for reform in bankruptcy laws.

Mr. Kerr was named a Queen's Councel in 1967, and during the same year Prime Minister John Roberts proclaimed the Halton West member "cabinet

Shortly after his appointment the new Minister of Energy and Resources made it quite clear pollution of air and water was going to be a major part of his term of office. "I intend to get the full

co-operation of industries (in control of pollution), whether three children including sons it's through gentle persussion or tough arm twisting or the full extent of the law," he noted. He plans to meet the Ottawa department concerned with pollution control and

rates sidewalks most? question splits council Tuesday

veteran councillor Jack Greer and freshman Peter Marks was obvious at Tweeday night's meeting of Acton council.

The subject was sidewalks and committee minutes when it was revealed that bids were being tought for tidewalks on Peel St., Brock St., Acton Blvd. and Wallace St.

Councillor G. McKenzie said he noticed that there was no mention of sidewalks in Lakeview subdivision and felt there was a real need for one along Elizabeth Dr. where the entire subdivision congregated and flowed out on No. 7 ludiway.

Councillor Earl Masales replied that the matter had been discussed but he reminded Mr. McKenzie that construction would depend on how much money was available. Mr. McKenzie sald that traffic on Brock St. was not as leavy as it was on Elizabeth Dr. and he could not understand the

Councillor Marks concurred with Mr. McKenzie's estimate of the situation. He suggested the volume of traffic on Elizabeth

Dr. exceeded any along any street in Acton, and since the area was the highest taxed in town it should deserve some consideration.

Councillor Massles said council was committed to other areas first before any consideration would be given to Lakeview Eldewalks. In councillor Greet's opinion Lakeview ratepayers would have to pay for sidewalks under local Improvement since there was no subdividers' agreement attached to the area.

Mayor Les Duby injected that holding the mill rate had been a prime concern of councils in the past and that there was now an epidemic of town work to be

Deputy-reeve Ted Tyler felt that if the Lakeview subdivision wanted, sidewalks all the ratepayers could contribute towards it. He noted several other areas in town had installed their own sidewalks on a local improvement basis.

Councillor McKenzie however was still not convinced.

He said "we can't argue about the need on Acton Blvd. and then not give the same consideration to Lakeview since

Planning board needs experience - Mayor Duby

Mayor Les Duby urged council at the regular meeting Tuesday to make an attempt to contact people with experience to reconsider serving on the town planning board. He said the recent resignation of chairman Bob Drinkwalter had caused some concern and the board was lacking experienced persons to deal with problems which are getting weightier as time goes

loitering

Acton O.P.P. laid a number of loitering by-law charges this week, marking the first enforcement of the by-law since it was introduced a year ago.

The book reads that an individual may not lotter after being requested by a police officer to leave. Constable Bruce McArthur commented that a certain group of local residents have been continually ignoring police warnings on the main

street. The offense is not streatable as a by-law infringement. However, If the followers are obstructing traffic and creating a public disturbance, it becomes a criminal offense and an arrest

can be made. The penalty for the by-law charge is a fine of about \$30 for a first offense and up to \$300 for subsequent charges.

"Can we do this when they haven't notified us of the chairman's resignation?" asked

councillor McKenzie. "I feel as the mayor we must get something done," replied Mr. Duby. "This is meant as no criticism of the present board but we are approaching the heaviest planning period in the town's history and the board needs all the experience it can

He also asked road committee to consider some sort of treatment on the road from MacDonald Blvd. to the Porter plant since the condition of the road was a hazard to traffic.

Let's not make the same mistake now as we did 10 years ago, Mr. Marks replied, suggesting it was time council got things done which had been neglected in the past.

Reeve Frank Cakes was annoyed by councillor Marks' comments. He said every council in the past has tried to do a job, and it was not a mistake to try to keep the tax rate down, He attributed it to reason, or common souse, rather than mistakes. The mayor recalled that the tax rate had four and a half mills chopped off it last year when mucli-needed work on the town streets was neglected. He suggested the councils of the past had done the best with what they had to work with. Councillor McKenzie reminded council that they had spent \$30,000 "in one lick" since they were over a barrel, on drainage in Lakeview but now they have a safety problem and

seem to want to avoid it. Later in the meeting councillor Greer taking his turn at the inquiry session suggested that councillors from Lakeview subdivision should take a look around town and see the needs of some of the rest of town.

Councillor Marks was not mollified by Mr. Greer's remarks and asked for some clarification meant. He suggested Mr. Greer was calling the Lakeview councillors selfish. He stated emphatically "Lakeview councillors have also considered other areas" and it was a gross overstatement on Mr. Greer's part to infer they hadn't.

At the regular meeting Tuesday pight, Acton Council:

* Read the amended swimming pool by-law three times and passed it. There are three minor changes in the by-law which passed last year. Depth of water in a swimming pool affected by the by-law must be at least 24 inches and capable of being swum in. Original testrictions on fencing have now been amended so other materials providing an equal degree of safety can be used. Council will insert an ad in the Free Press to notify pool owners of the by-law.

" Endorsed a resolution from the city of Kitchener complaining. .. about the government takeover of assessment in the province. Acton Council felt the meanment program should be carried out on a regional basis. Councillor Marks said he could not agree with several statements in the Kitchener letter to the provincial authorities and voted against st. Deputy-Reeve Ted Tyler also voted against the
