Council met at 8 p.m. with Councillors Anthony, McMillan, McIntyre and Rush present. It was moved by D. McIntyre and seconded by J. C. Rush that W. C. Anthony take the chair. Carried.

The minutes of the two previous meetings were read and confirmed. Communications were received from Victoria Young Peoples Guild, Toronto; thanking the Council for the use of the park for their picnic; J. A. Thompson giving estimate of funds required for Public School; W. H. Moore asking for an increase in wages for looking after cemetery; Imperial Oil Co. re Queen St. payments; Department of Public Highways re payments; R. H. Thompson & Co.; J. W. Kennedy & Son; S. H. Hays; Iron, Tube and Lead Co.; Bond Hardware Co. and Canadian Brass Co. re price of galvanized iron pipe.

Clerk was instructed to write Messrs. Sam Walker and J. B. McKenzie asking for a reply re Main St. south sidewalk. Also to write Public Works Department, Toronto, to get information re memorials and Mr. Alex Reith, Sarnia, for affidavits re erecting Georgetown into a town.

**Esquering Council**

The Council met pursuant to adjournment, the Rev. in the chair, members all present, minutes of last meeting read and confirmed.

Hampshire Elliott: That the treasurer pay W. H. McMillan the sum of \$10.00 for one day's board and 16 yards gravel supplied and work done for T. Kennedy, P.M. Carried.

Elliott Thompson: That the treasurer pay the following account: A. Anderson for building concrete bridge on main line Georgetown and Nassauville, on opposite lot 5, \$162.69. Carried.

Melchior Thompson: That a grant of \$20 be given R. H. Fleming for school taxes. Carried.

Elliott Thompson: That Jonathan Walker be paid \$12 for operating grader 4 days Sawyer Massey Co. \$120.00. Carried.

Melchior Thompson: That the sum of \$15 be granted to Georgey Hinds for graveling 25 side roads on the 3th line, \$150. J. A. Thompson, 1 day hauling gravel with team, 36.00. Carried.

Hampshire Elliott: That the treasurer pay John Grant, P.M. the sum of \$40. This sum to be collected out of Limehouse and Newmarket. Carried.

Provincial Highway: The department of Public Highways has deposited in the Registry Office a preliminary route plan, showing the location of Dundas Street between Nelson and Trafalgar. It is proposed to add a provincial highway and give notice in accordance with Section of the Provincial Highway Act, that the road should become an arterial in the Crown and under the control of the Department on 31st inst. at noon.

Debenture Debt in Halton: According to the government report, following are the debenture debts, municipal and school, of the five towns of the County of Halton: Acton, \$56,505; Georgetown, \$77,117; Burlington, \$261,399; Milton, \$28,750; Oakville, \$118,779. This shows Acton's debenture debt to be considerably lower in the lowest of the towns of the county. We will be able, however, to advance the above aggregate by a considerable sum when the new waterworks debentures are floated.

Increased Pay of Road Men: The Board of Arbitration which was appointed to settle the dispute between the Toronto Suburban Railway and its employees held session on Tuesday, and it was agreed that the men should have a minimum pay for two hours a day, regardless of the time they worked. The dispute concerned haulmen, operators and other mechanical workers, who started out by asking a dollar an hour but agreed to drop their demands to 45 cents. This would give them a 5 per cent increase. There are only 25 men concerned. Everything points to a successful adjustment of their difficulties.

Milton's Chief after Express Motorists: W. A. Chapman, Chief of Police of Milton, made the following announcement in the Champion last week: "Notice is hereby given that the Provincial Inspector has complained about the law enforcement of the law in respect of driving of motor cars and has stated that unless the law is immediately enforced he will appoint an official to enforce the same. This notice is to inform all parties that in the event of any violation of the law, prompt action will be taken against all violators of the Motor Vehicle Act."

A similar notice by Georgetown Chief would be in order.

Migratory Birds: The Ottawa Journal outlines the new regulations issued by the Department of the Interior for the protection of migratory birds in Canada. These regulations aim to prevent the slaughter of birds by means which give them little chance of escape. Important restrictions are placed on the kind of firearms that may be used and on the methods of hunting. No migratory birds may be hunted henceforth with shot guns larger than ten gauge. The guns of automatic, swivel, or machine-gun type are prohibited, and the hunter must not employ power boats, motor boats or airplanes. Shooting of migratory birds between sunset and sunrise is prohibited. Other regulations are also in the right direction. The department of the Interior in these regulations has not taken into consideration the protection of the nests after the young birds have emerged from the nest. The same act is more restrictive than many a gun in the hands of a small boy.

**Game Law Changes**

Some important changes have been made by the Provincial Government in the Game and Fisheries Act, which became effective on June 1st. The hunting season for moose, deer or caribou, north and west of the French and Mattawa Rivers, is from the 25th of October to the 30th of November. This is longer than the law previously allowed for deer. Partridge may be shot between the 1st and 29th of November only, and no person shall take, kill or have in his possession more than five birds in any one day, and more than ten for the season. No person shall be shot or appear at any time, nor shall any animal or live house or bear, and no person shall, take or molest any deer or moose while in the water.

**Robbers Steal Half-Ton Safe**

Quilley experienced a visit from a new species of "motor bandit" on Saturday afternoon. The bandit demonstrated that the motor truck, plus nerve and inventive genius, may open up a new and profitable field of exploitation to burglars.

Late on Saturday night or on Sunday morning a truck drove up to the office of the Hillier Fuel Company. Evidently a good sized gang of burglars, with tackle, must have accompanied the truck, for they rigged a winch, slung out through the window of the office a 1200 pound safe and carried it away.

The safe was found yesterday in a field near Clarkson, about five miles west of Quilley, with the door blown off. Only about \$30 rewarded the burglars' enterprise, but a number of burglarized stores' funds had been kept in the safe up to a few days before. The county and town police are investigating.

**Drugs Not to be Stamped**

Local druggists as well as various retailers at the buying public in general will be pleased to learn that the stamp tax on patent medicines, toilet preparations and a hundred and one other articles sold by the druggists of the land during the last few years, has been removed. The new amendment to the Stamp Act, passed June 26th, and from now on no stamp will be affixed or have to be paid for when a purchase of any of these articles is made. But why should the tax be taken off? It is understood that the wholesale dealers have to pay the tax. The country must pay the tax, but surely some way can be devised that will not involve so much petty and costly detail as the stamp method. Yet the stamp method is better than sending in duplicate checks of every sale.

**Three Gallons for Doctors**

Chairman J. B. Elwell, of the Ontario License Board, has announced that on the authority of an order in Council, dated July 2, duly qualified medical practitioners in the Province will be allowed to keep for purely medical purposes three gallons of liquor on stock after August 1, 1920. At present physicians and surgeons are permitted to keep ten gallons.

**See Value of Motor Truck**

French Business Men Realize That Their System of Freight Transport, Lately is Obsolete.

That the war brought to France an object lesson in the utility of the motor truck as a means of freight transportation appears in plans now under way to develop a long haul system. It is hoped thereby to quicken the movement of goods and lessen the importance of various business interests with the slowness of railway and waterway traffic.

**May Restricted Sale**

Municipalities in Ontario hereafter may, by passing by-laws, limit the sale of Temperance beers to the holders of standard hotel licenses. At present restaurant keepers in almost every city and town are selling beer of less than 2 1/2 per cent. There is little control of its sale. An order in Council has been passed and published in The Ontario Gazette, which may cities, towns, villages and townships may pass by-laws for granting the exclusive right of reselling in the municipality such products, commonly called temperance beers, to keepers of standard hotels licensed under the Ontario Temperance Act. Such by-laws may be passed after September 1, 1920.

The new Dominion Government tax on "stamps" will be collected, 30 hours of revenue minus after the first of August. The stamps will be in denominations from 1¢ to 10¢, for \$1.25, 25¢, 50¢ and every multiple up to \$10. The stamps will be issued in July and August. The stamps will be collected by the Internal Revenue Department at cost to all municipalities.
