New Stamp Tax
For the public information we
give the following particulars with
reference to the tax on cheques.
The reference to cheques states
that all cheques issued after July
31st of this year, and which are
negotiated in Canada, must bear
stamps attached by the drawer, in
accordance with the new regula-
tions as follows:
For amounts up to \$50, 2c tax.
Over \$50 and up to \$100, 5c tax.
Over \$100 and up to \$200, 10c tax.
Over \$200 and up to \$500, 15c tax.
Over \$500 and up to \$1,000, 20c tax.
Over \$1,000 and up to \$2,000, 25c tax.
Over \$2,000 and up to \$5,000, 30c tax.
Over \$5,000 and up to \$10,000, 35c tax.
Over \$10,000 and up to \$25,000, 40c tax.
