### VOTING NEXT MONDAY

**ON CEMETERY DEBENTURE BY-LAW AND DELIGHT SAVING—WHO CAN VOTE?**

All property owners in town should cast their vote in favor of the Cemetery Debenture By-law next Monday. The cemetery has been vastly improved by the outlay, and though still a little larger than was at first anticipated, it was work that was absolutely necessary. We say vote for the By-law, because if it is defeated there are only two alternatives, viz:—1—Raising \$10,000 next year by direct taxation which would mean an additional 8 or 9 mills on our assessment, 2—Having a Special Bill put through parliament to validate the issue of debentures. The first would make our taxes pretty high next year and we feel they are high enough now, and the second would add very materially to the sum already expended. Only property owners are entitled to vote on the Debenture By-law. Voting on Monday next Dec. 1st.

Those who drink water will be pleased to know this. Our milk supply has greatly improved and is one of the best in the county. There are still a few nuisances in town which are hard to correct without a sewerage system.

Ex-Mayor LeRoy Dale, who was nominated for Mayor, regretted he was unable to attend the evening. He thanked the ratepayers for the honor they had conferred upon him in the past. He also wished to thank his friends for a great kindness they had shown to him during his trying illness, and to deny reports circulated regarding his death.

It was no year to increase taxes and have surplus money going to the pockets of the town and believed all councils had done what they thought best for the town. He had no thought of leaving town as reported.
