### Administration Costs Rising

Council's action Monday in increasing honorariums to mayor and councillors is a further step away from a few year's back when people served for ers for this office in future. nothing on public bodies.

Certainly a man gives a great deal of time nowadays to public office. The actual council meetings are only part of the job. There are committee meetings as well, plus the time-consuming matters which taxpayers bring to an individual's attention.

We are quite in agreement that a council member should be reimbursed for out-of-pocket expenses. If he were not, then it would be increasingly difficult to find men willing to render public service unless they were financially able to afford it.

We definitely agree that the mayor of a town such as ours should be adequately recompensed, for he more than any other council member is at the beck and call of the electorate. When one thinks of the functions he attends in his capacity as mayor, the hours he spends with prospective industrialists, town planners, subdividers, machinery salesmen, and in the municipal office supervising town routine, then

it becomes a fact that he must have a generous pay ment from the public purse, or we shall have no tak-

But we feel that council should deliberate much longer than they did on Monday, before setting the mayor's honorarium at \$1,000, exactly double what it was a year ago.

The "raise" from \$5 to \$6 for council meeting fee is also hard to justify, for it brings the question of measuring such public service in dollars and cents. The theory of a councillor being paid should be to overcome any out-of-pocket expenses which his position entails,, plus some small token for the hours he spends at the job.

If it is going to evolve into a cash payment for time spent on public business, then we must re-evaluate our whole theory of public service, and in time a councillor will become merely a paid part-time public employee, rather than a citizen who serves his community for the privilege of contributing his talents to the community good.


