

Halton Natural Gas Still Seeks Franchise

"We'll be coming to council in Janusry to seek your consideration for 3rd reading of a by-law to give Halton Natural Gas Co. a distribution franchise." W. H. Besley told council Mon-

Mr. Besley said that building of the trans-Canada pipeline between Toronto and Montreal next year, has given his company, which is connected with the Lakeland company in the USA, a chance to provide rates which will be more favourable than any other company because of a "bulk purchase" arrangement. Halton Gas will be in a position to supply gas to George-

town by late summer or early fall. Questioned whether his company would be using gas from the local Antony Company, he said Halton Gas has written to Anthony offering to purchase their gas at the prevailing market price.

To the Ratepayers of the Town of Georgetown:

As you are, no doubt aware, I am a candidate for the Council in the Municipal election to be held on Monday, December 12th next, and owing to the shortness of the time to canvass, it is impossible for me to canvass everyone personally for their support so I felt the only thing to do, so I could reach every one of you, was to write this letter.

There is a great disquietude among the electors as to where we are going and they are alarmed about the ultimate financial position of the fown. They feel that for some time to come they are going to have increased taxation and a mounting debt with no effort at all being made to keep our financial position sound.

If you will examine the interim financial statement for the year 1955 you will find that the deficit for the year 1955 is \$8021.18 but upon examining the receipts you will find an item - the fourth from the Lottom of page two. This is a payment which reads as follows - "Payment in lieu of Tax, Delrex \$39,657 77." This, I understand, was a voluntary contribution by Delrex to help balance the budget for the year 1968. liad this not been made the deficit for the year 1955 would have been \$47,878.95, which amounts to ten mills. Does anyone think with all the projects on hand for next year that the Town is going to be in any better position next year than they are this year and is Delrex again going to foot the bill? How long can this continue? The ratepayers must remember that Deirex has a contract with the Town of Georgetown and the Council has placed itself in a very unenviable position and can it be any wonder that a great many citizens are beginning to ask as to whether the Council are acting for the people who elected them or Delrez.

As a result of all this building activity capital expenditures are sure to multiply During the past year \$232,309 73 was spent on projects, for which Bonds are to be issued, and I feel that there will be expended close to \$500,000,00 or more, for which Bonds will be issued, on projects for the year 1988 so that in two years (1955 and 1958) close to \$750,000.00 will be added to our debt. The Georgetown, as it exists at the present moment, cannot carry this debt, and we are simply pledging our credit on the strength of something happening in the future and which no one can be certain will happen.

I have always been in favour of the town growing and for all brogress, but within the means of the Municipality, and to never allow expenditures to get out of hand so that taxation would become a real burden to the people. In fact, I was mayor at the time Smith and Stone Limited first started in Georgetown and spoke from a public platform in favour of having them locate here and to ask the ratepayers to pass the By law that would enable Smith and Stone to locate here.

I have always been a friend of labour and during my tenure of office in town council I received support of a very large mejority of the labour vote. I always tried to keep the affairs of the town on an even keel. I had one key principle in my municipal career and that was to always do what was honest and right and in the best interests of the ratepayers as a whole. No one ever had any chance whatever of making me deviate from that course. I give this as the reason for my long tenure

I feel that with the experience I gained in my ten years on the Council, nine years of which I headed the Council, and in view of the fact that I have been advising Municipalities regarding Municipal law for the past forty years, I may be able to help in the proper dealing with the problems that will arise within the next year or more. It is for this resson that I am soliciting your vote for Council.

It has come to my notice that reports are going around as to whether I am well enough to undertake this work. I have purposely refrained from running for any other position than Councillor so that I can give my time to the affairs of the Town only and I would, under no circumstances, run unless I felt I was able to discharge my duties of a Councillor properly
