## SIX NEW MEMBERS JOIN THE 1956 HALTON COUNTY COUNCIL

Reeve Stanley Allen, Georgetown, was unanimously chosen warden at the inaugural meeting of Halton County council last Tuesday. Reeve Harold Adkins, Nelson, was also nominated but withdrew in favour of Mr. Allen.

Six new members took their seats at the first session of the 17-man council. They include: Reeve William Card and Deputy-reeve Herbert C. Merry, Oakville; Deputy-reeve William Wilson, Acton; Deputy-reeve Douglas Sargent, Georgetown; Deputy-reeve R. C. Cunningham, Milton; Deputy-reeve George Currie, Esquesing.

Other members are: Reeve Jack Hargrave, Acton; Reeve Harold Adkins, and Deputy-reeve Fred Walker, both of Nelson; Reeve Robert Marshall and Deputy-reeve Donald Bath, Trafalgar; Reeve A. R. Service, Nasagaweya; Reeve Thomas Millward, Bronte; Reeve R. H. Shannon and Deputy-reeve F. C. Atkinson, Burlington; Reeve Sidney Childs, Milton; Reeve Walter Linham, Esquesing.

Committees for the year are, with the first named chairman: Agriculture and Reformation — Reeve A. R. Service, Currie, Marshall, Walker, Millward, Merry. Assessment — Reeve William Card, Linham, Adkins, Bath, Wilson, Atkinson.

County Buildings — Reeve Harold Adkins, Hargrave, Sargent, Childs, Service.

Finance — Reeve R. H. Shannon, Hargrave, Bath, Currie, Millward. Printing and Education — Reeve J. Hargrave, Linham, Cunningham, Sargent, Merry.

Special Communications — Millward, Childs, Walker, Wilson, Cunningham. County Roads — Reeve Robert Marshall, Service, Hargrave, Walker, Linham.

Hospital — Reeve Walter Linham, Atkinson, Marshall, Merry, Millward.

Considerable argument arose when a by-law was introduced to enter into an agreement with the town of Burlington in connection with a \$10,000 expenditure on the county road, Brant St. Reeve Robert Marshall and Reeve A. R. Service questioned the amount, informing council a figure of \$7,000 had been previously suggested.

Reeve Shannon explained it was the intention to put the expenditure in resurfacing the road but the Department requested a reconstruction program. As \$7,500 had already been paid to Burlington for this work, council, it was explained, could not come under terms of the provincial grants unless it approved the agreement. Members approved the by-law

when it was learned the amount already paid would not be subsidizable if the agreement was not signed and the county would then be out the \$7,500 expenditure.

Several appointments were made, including the members to the board of the Halton Centennial Manor, R. H. Shannon, J. J. Stewart, Stanley Allen, William Card and A. R. Service, Halton Health Unit Board: Ray Thompson, two years; Reginald Smith, one year; Deputy-reeve F. C. Atkinson and Reeve Harold Adkins, county council's representatives for one year. Halton Planning Committee: Reeve Donald Bath, Deputy-reeve Doug Sargent, Deputy-reeve F. C. Atkinson, Deputy-reeve Fred Walker and Deputy-reeve R. C. Cunningham. Reeve A. R. Service and Deputy-reeve Fred Walker were appointed to the Halton County Park's Board for the year.

The county engineer and the road committee were delegated to attend the Good Roads convention with the county paying up to \$100 expenses. The annual fee of \$25 was also authorized. The agriculture committee was also delegated to attend the annual convention and the annual fee of \$50 was authorized.

The building committee was authorized to review and report on the advisability of making necessary extensions to the jail kitchen, as well as the sanitary requirements.

# STOP when School Bus STOPS

An amendment to the Highway Traffic Act which becomes effective February 1, 1956, makes it an offence to pass a stopped school bus.

ON AND AFTER FEBRUARY 1st when a motorist overtakes a school bus which

- is marked on the rear SCHOOL BUS DO NOT PASS WHEN BUS IS STOPPED and Red, Rear, Flashing Lights are operating and
- is stopped upon a highway outside a city, town, village, police village or built-up area for the purpose of receiving or discharging school children

he shall STOP his vehicle and SHALL NOT PROCEED until

- the school bus resumes motion or
- the driver of the school bus signals him to proceed or
- the flashing signals are no longer actuated.
