council opinion.  
The mayor said he had been discussing pros and cons of Delrex since last June with a large number of ratepayers and his conclusions are based on what he believes to be a consensus of opinion.

When he was elected mayor in 1952, the town needed industrial land. In the old town limits only one property was suitable for this, but it was not available. When Delrex came with its proposal in 1954, it seemed the answer and council of that day signed an agreement which has led to a large area of industrial land within town limits.

Georgetown's strategic location near the seaway, with adequate hydro power and in the centre of Ontario's population hub leaves little doubt that industry will come in future, he said.

"I often wonder what our newer residents must think when we say that we don't want any more houses and that houses are like bilities" he remarked. "Certain-

ly the new residents we have are making their contribution in churches civic and fraternal organizations."

Despite concern over taxation here, he said, two neighbouring towns have tax rates ten mills higher. In 1964, the mayor said, he found no one not in favour of the Delrex agreement. The firm has since been most fair with the town, he said, and in no case where council has solicited help have they turned it down. In 1958, concerned with the tax rate, Delrex had been approached and had made a \$30,000 gift.

"We could sit all night and debate whether annexation was a wise move or not, though I personally think it was," said the mayor, "and we'd be no farther ahead because only time will prove it one way or the other. One thing I'm sure of, the town and Delrex have chosen to become partners, and a partnership is successful only if there is cooperation on both sides."

Disputing a statement of the mayor, Cr. Hyde said he was not pointing a finger at new residents, but at the man who said he would give Georgetown industry. Taxes are four or five times higher than they were in 1947, he said. Industrial land was available at a price in 1954 just as it is today, he said. (This was refuted by the mayor and Reeve Sargent who said they had visited the land owner on behalf of Ontario Steel Products which later located in Milton and had been told the land was not for sale.)

"You say no one opposed annexation. I was a town employee then, and I did," said Cr. Hyde. "I said the town could get better without getting bigger."  
Cr. McGillivray said he had been told by Mr. Marsland of the Harley-Kay firm which later moved to Kitchener, that they would have built their new plant on the land being discussed, but could not buy it.

Prior to the council debate, several ratepayers present stated views on the question.

George Stephens, 62 Rexway Dr. introduced himself as being with the Heslop organization, that he liked living here and hoped the firm would not have to be leaving Georgetown.

Mrs. Joseph Lupton, 50 Byron St. protested building any more houses until there is work for those who live here now, and said she was speaking for neighbours as well as herself.

S. W. Orr, 4 Market St. said he had taken a telephone vote of his Southwest Georgetown Ratepayers Association and the feeling is that there has not been enough time to study what effect the proposal would have on the town. He suggested a month's delay, and a vote of ratepayers on the scheme. It is his personal opinion that it will cost Georgetown half a million dollars.

Mr. Orr tried to speak again later as council ended its deliberations but was told by the mayor that procedure didn't allow when a motion was on the table. "I represent 200 ratepayers and it won't be the last you hear from me" promised Mr. Orr.
