Preston Man Assumes Post With Hospital Association

R. Alan Hay, of Prescott, was named the new full time Executive Director of the Ontario Hospital Ass'n. recently, the voluntary organization representing all 228 public hospitals and many allied health institutions in Ontario. Mr. Hay, one of the best known hospital personalities in Canada, succeeds Stanley W. Martin, who in May moved from the Association to become Chairman and General Manager of the Ontario Hospital Services Commission.

Mr. Hay's appointment, which takes effect August 1st, was announced by OHA President Glen W. Phelps of Orillia following a special meeting at Association headquarters in Toronto.

A Board member and former chairman of the Brockville General Hospital, Mr. Hay is the first trustee to hold the chief executive post of the Association in its forty-two year history. Mr. Hay, who is equally well known in agricultural circles as one of Eastern Ontario's leading apple growers, first became involved in hospital affairs as a trustee of the Brockville hospital. In 1959 he was elected to the Board of Directors of the OHA and was President in 1964-65. He is also a Director of the Canadian Hospital Association and a member of the province-wide Council of Regents established by Ontario's Education Minister last year to advise on the establishment of Community Colleges.

Commenting upon the appointment, President Phelps said: "The hospitals of this province

are indeed fortunate in securing the full-time services of such an able and energetic man as chief executive of the Association, especially in these times of evolution in the role of the community hospital. Mr. Hay has long been one of the most articulate and progressive spokesmen for hospitals in their relationships with government, and a firm believer in the importance of the continuing role of local hospital boards. Under his leadership we can look forward to a steady expansion of the Association's services to hospitals in the fields of education, consultation and research."

Mr. Hay, who is married with two teenage daughters, came to Canada from England after World War II. His distinctive monocle is a legacy of wounds received near Tunis, North Africa in 1943, while serving with the 18th/5th Lancers. He has been an energetic force in community affairs since settling at Hawthornes Farms in Prescott, and in 1960 was named Prescott's "citizen of the year."

Harold G. Dillon, who has been Acting Executive Director of the OHA since Mr. Martin's departure, will continue in that capacity until the new Executive Director arrives. He will then become Mr. Hay's senior executive associate within the organization.

In addition to its services to hospitals, the OHA also operates the Ontario Blue Cross plan, which covers close to 2 million persons in the province for hospital and related health expenses.

Charge of Shooting at Car Dismissed at Lengthy Hearing

In a preliminary hearing that occupied about two hours in Thursday's magistrate's court, a Hornby man won an acquittal on a charge of causing an injury to 18-year-old Kenneth Rusk by discharging a shotgun at a motor vehicle on June 18th. He had elected trial by a judge in a higher court.

Rusk, who lives in the Hornby area near the accused, said that at about 1.50 a.m. on June 18th he and Victor Jakaitis, a neighbor, had started out in the latter's car to look for their brothers, who had gone to a ball game in Oranagh the previous evening and who had not returned home. They were proceeding up the Eighth Line and drove into the driveway of a brother of the accused who lives nearby in order to turn around. They then noticed him standing in the road with a gun. He had just stopped another car driven by Rusk's father, the witness said.

"He stopped us and told us to identify ourselves," Rusk told the court. "I was getting ready to get out of the car. Jakaitis started it. The accused shot. The door was open. I felt something hit the side of my hand. I looked and there was blood coming out. I got out and walked back to where he was. He was standing there telling his wife to phone the police."

Rusk said that previous to being ordered to stop, he and Jakaitis had been shining a flashlight on the roadside ditch in order to see if their brothers were hiding there. Jakaitis said the pellets from the shotgun had done about \$50 worth of damage to the car's upholstery.

Constable Dennis Kaye, who investigated the incident, said the gun was unloaded when he examined it, and he found an empty shotgun shell by the side of the road. He said the skin of Rusk's right hand was ripped and bleeding. There were chips in the paint on the right-hand side of the car and a chip in the steering wheel, and five holes in the inside right door panel. A fragment of lead was taken from one hole.

Rusk was taken to Milton District hospital where his injured hand was treated.

"I submit the accused was criminally negligent in firing at the car," said Crown Attorney Peter McWilliams. "If he had fired with the intention of hitting the occupants he would have been charged with intent to maim. There was no right on the part of the accused or anyone else to use force to defend themselves. The accused had no power of arrest. There can be no justification for the accused or anyone else to use force. The accused needs to be straightened out on what his rights are in this country."

"The court disagrees with the remarks made by the Crown Attorney in a great many respects," replied Magistrate Kenneth M. Langdon. "Any person

who is the owner of property may arrest without a warrant

any person whom he finds committing a criminal offence in relation to that property."

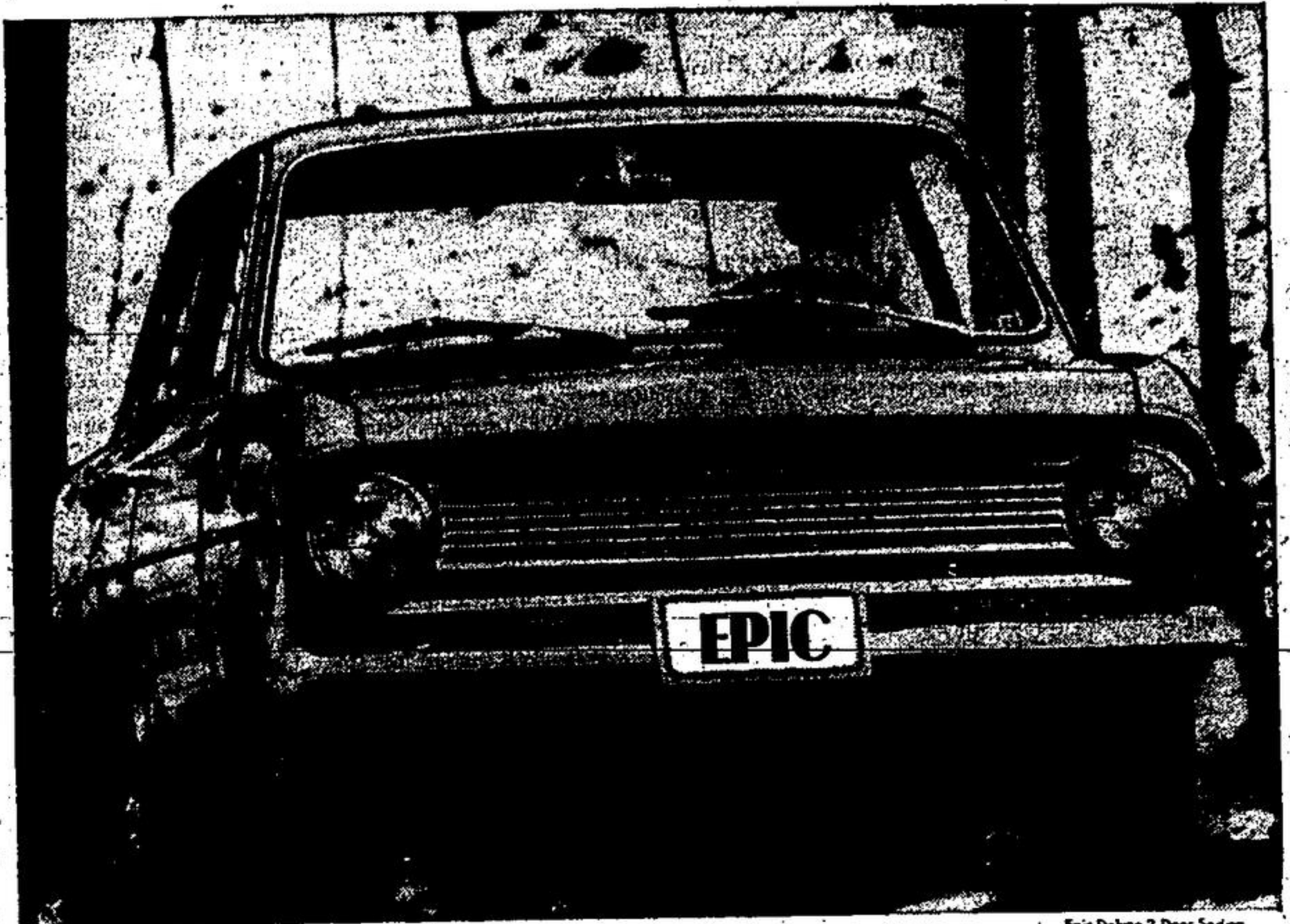
DISMISSED CHARGE

"The court is unable to find there is sufficient evidence to warrant your committal for

trial," the magistrate told the accused in dismissing the charge.

Crown Attorney McWilliams then laid a charge against the accused of having in his possession an offensive weapon for a purpose dangerous to the pub-

lic peace. He again elected trial by judge. Magistrate Langdon adjourned the case one week for a preliminary hearing.
