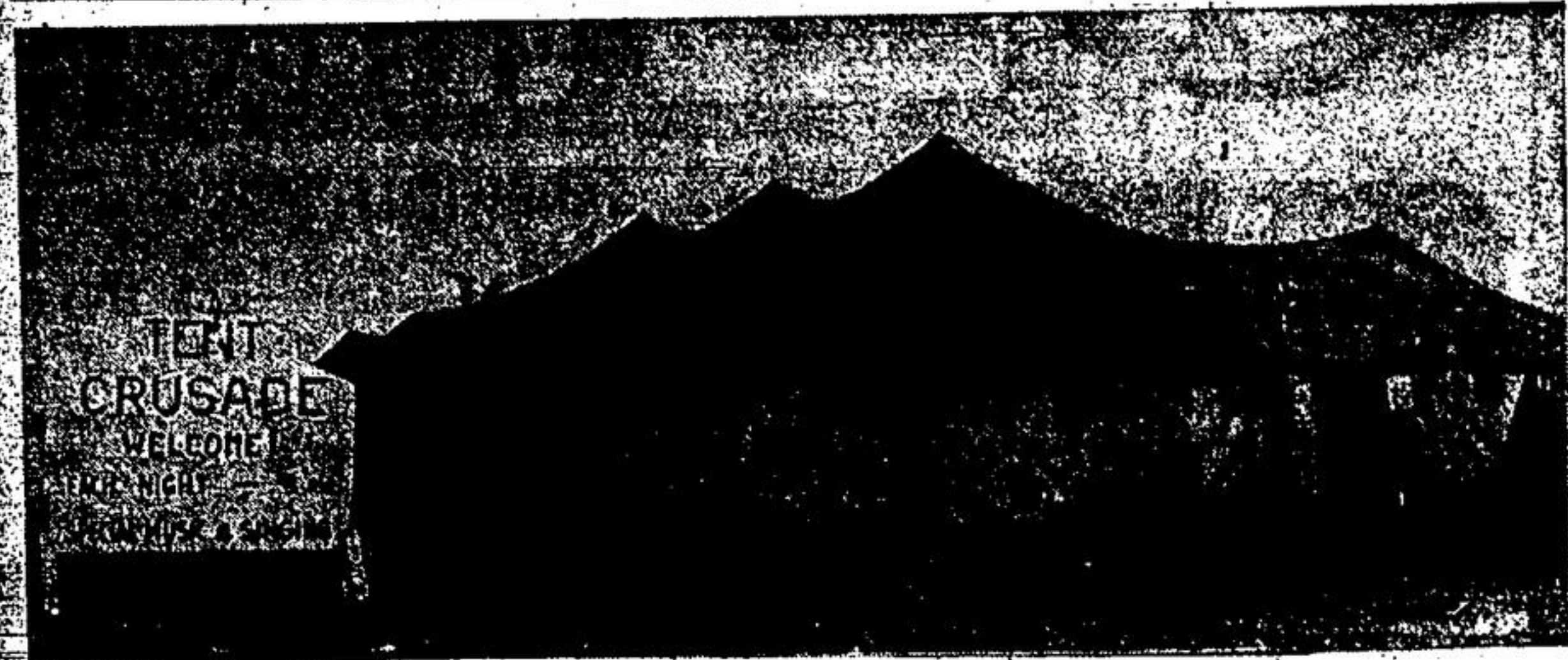

"Trick Photography" Charges Irrate Councillor at 'Times'

Fred Harrison challenged the Credit Valley Conservation Authority to come and look at Georgetown's garbage disposal site "and bring all the reporters they want", when letters from both the Authority and the Ontario Water Resources Commission were read to Council, Tuesday night.

A copy of the letter from the Credit Valley Authority to the Water Resources Commission, stated that concern had been expressed in the area about the possibility of pollution from the town's land fill operation entering the river.

The letter claimed that a Water Resources Commission report in 1963 had indicated that the operation on this site could become a source of pollution, and asked the Commission to investigate.

At the conclusion of the letter, it listed names to whom copies had been sent. These included the Peel and Halton County health officers, Mayor Gibbons, William Davis, MPP for Peel, George Kerr, MPP for Halton, and the Brampton Times and The Globe and Mail.

Cr. Harrison took exception to the copies going to the newspapers. He dubbed photographs which appeared in the Brampton Times, "trick photography," saying one of the pictures showed garbage just dumped off the truck, while another wasn't town property.

Plan Masonic Lodge Hall In Highway Building

Credit Masonic Lodge, which has rented a third floor hall over the Canadian Imperial Bank of Commerce for 85 years of its 97-year history, is planning new quarters.

The lodge has purchased a 1 1/2 acre property on No. 7 Highway, just west of the town limits, and plans to build a lodge hall next year.

The property, acquired from the Ruddell estate, is near a group of suburban homes which have been built on the property in recent years. It has 125 ft. of highway frontage, and a depth of 500 feet towards the CNR railway tracks.

Georgetown's fourth bank is scheduled to open on Main St. this fall.

Toronto-Dominion Bank will occupy part of the new Sidmac building, presently under construction beside the Municipal Building. The bank will lease part of the building along the James St. side.

The building takes its name from Sid Silver and Sam Mackenzie, partners in Sidmac Realty Co.

Ray Howson has been transferred from Millbrook to be first manager of the new branch. He has already moved to town and with his wife and family is living at 57 Stevens Crescent. Until the branch is ready to open, he is relieving as manager at Waterford.

Toronto-Dominion has 680 branches across Canada and boasts that its founding in 1856 makes it older than Confederation. The bank has been watching Georgetown as a possible location for some time, and the Sidmac Building has filled the bill.

The building is being constructed on the site of the old White Rose service station which was razed to make way for it.

Mr. and Mrs. Howson are both natives of Clarksburg and she is the former Fern Osborne. They have 3 children, Bob and Debbie, who will be attending high school and Jerry, who will be a Grade 7 student at the new Centennial School. They are members of the United Church.

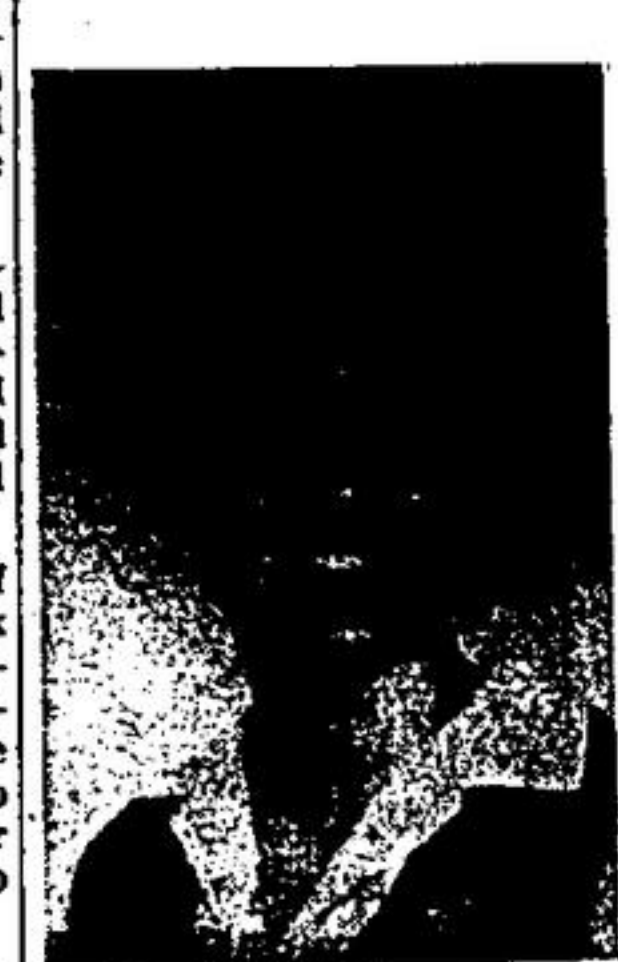

Landfill Site Closed Week-Ends and Holidays

Over the opposition of Crs. K. Hyde and R. Ballentine, a motion to close the gate at the town garbage disposal site between the hours from 5 p.m. Friday till 7 a.m. Monday, and on holidays, was passed by Council, Tuesday night.

Cr. F. Harrison explained that the site is in good shape now, but can only be kept this way if there is some control. He claimed this action was suggested a few years ago, but a key was made available so the site could be used on week-ends.

The mayor wondered how men who work all week are going to get rid of big articles. "I think it is a hardship," he added.

There were no serious fires through the week, despite the fact the siren wailed four times.

Last Tuesday afternoon a car caught fire as it was going through Norval, but was quickly doused by the local fire department.

Saturday afternoon a grass fire up near Silvercreek sent the firemen out, while Sunday afternoon a call came in from Terra Cotta playground, but was cancelled later. The fireguards had handled the accident themselves, with no difficulty.

A call to Halton-Peel Trust Company on Main Street (the former Christian Reformed Church) found smoke damage and no trace of fire. However, after a lengthy search a small fire was found down inside a cold air vent. Chief Erwin Lewis feels children dropped something lighted down the vent. Firemen found traces of other small fires in the built, which he felt had probably been started by the same children.
