

## Deny Reeve's Request for Cedarvale Finance Report

A motion to ask the Cedarvale Centre Board for a financial report, and list of rentals and charges, was defeated, but not before some angry words were exchanged at council meeting Monday night, Feb. 13th.

Reeve William Hunter the mover of the motion, claimed it was only right that a financial statement be received.

"It would be done by the town auditor anyway in the course of his duties," snapped Cr. William Smith.

"The time has come to stop picking on Cedarvale," retorted Cr. Wheldon Emmerson. "They had very little money to work with. Everyone felt it was their project, and as taxpayers they were paying for it. The Board had no yard stick to go by, and only tried to be fair," Cr. Emmerson pointed out that the rates are to be reviewed this year.

"The people on the board might take a dim view of having their actions questioned," concluded Cr. Emmerson.

"I'm throwing no slurs at anybody, I'm only asking for a

statement and their rates," replied Reeve Hunter.

"There's nothing personal about this," added Deputy Reeve Speight, the seconder of the motion, "I would like to know how much money it might take this year."

Cr. Robert Francis, a newly elected member of the Community Centre Board, claimed Cedarvale was now getting off the ground, and would become self-supporting.

"We all know how Reeve Hunter feels about Cedarvale," began Cr. Smith. "To get this information he only had to ask the treasurer Chris Walker. This is personal sniping, of the nature only Mr. Hunter can do. If Hunter will accept my position on the Cedarvale Board, I'll be happy to resign."

"This report should have been in the finance chairman's hands long ago," Reeve Hunter charged. "I asked a month ago, and now I'm just asking for information to which I'm entitled."

On a tie vote the motion was lost. Cr. Smith, Francis, Emmerson and Ballentine opposed the motion.

## Involved Red Tape For Shipment of Elk

Five elk, which were to join five buffalo at North Halton's Rattlesnake Point, may not arrive for another six months, Field Officer Dave Murray of the Halton Region Conservation Authority said this week.

"The animals have to get clearance from several government agencies, including the Department of Agriculture and the Department of Lands and Forests," said Mr. Murray. The elk will probably come from Elk Island Park in Alberta, where large herds share the range with buffalo. Both elk and buffalo are gifts from the Federal Government.

Mr. Murray added that the Authority executive has approved the proposed elk transfer in principle, but has given no total commitment. "There's still quite a bit of work to do," he said.

Rattlesnake Point is a North Halton beauty spot on the Niagara Escarpment near Milton, and the five buffalo that range there are now nearly two years old. "They're doing very well," said Mr. Murray, "and should come into full maturity in another year."

## Estimate Bridge Improvements Will Cost Georgetown \$25,375
