Barn, House Fires Cause Estimated \$60,000 Loss

Two major fires last Friday morning caused property damage estimated at close to \$60,000.

A barn fire at Alluvialdale Farm, operated by Wilfrid Leslie & Sons on the Town Line near Union, called firemen from Georgetown and Chinguacousy.

The fire broke out suddenly about 6.15 a.m. while the head of cattle was being milked. Mr. Leslie, sons Tom and Keith and an employee, Ray Beckett, were able to shepherd the entire herd to safety. The barn, and an adjoining milk house, were completely destroyed, as was the season's crop of hay and straw, a wagon, hammermill and feed mixers.

The 63' x 93' barn, one of the largest in the district, was built sixty years ago by Mr. Leslie's father, the late Thos. L. Leslie. The loss, estimated at over \$50,000 is partially covered by insurance.

Another district farmer, Harry Moore, suffered a similar loss a week ago.

Later that morning, a fire at 12 Park Ave. home of Mr. and Mrs. Brian Hill caused damage to house and contents of over \$5,500.

There was heavy smoke and water damage. A television set, bedroom furniture and clothing were destroyed.

"We have pinned everything right down to the size of the units, side yards, backyards, parking space," remarked Cr. Francis.
