Sideroad, pressured Esquesing Council to instruct Indusmin Quarries they must use 22 Sideroad to 25 Highway as a truck route through the township.

In the meantime, said the resolutions, which was churned out over almost two hours of discussion, the township will meet with representatives of the Departments of government involved to see about a possible development road for the use of trucks.

Reeve Currie, shaken by pressure Two separate groups

Council was faced with two separate groups of ratepayers - one from 17 Sideroad and the Fourth Line and the other from Limehouse both asking council to forbid trucks from using the routes in front of their homes. Both groups after discussion, later advocated that council designate 22 Sideroad and 25 highway as the route for trucks from the Indusmin quarry, which is situated between the Third and Fourth Lines, below Acton.

Dick Looye, speaking for ratepayers from the Fourth Line and 17 Sideroad, insisted the township council had the power to designate the route trucks must take. "Why are you dragging your feet on this?" he asked in a voice husky with emotion. "There are lives at stake here,"

Reeve Currie, shaken by pressure from both groups, said council wanted to put trucks on 17 Sideroad to alleviate the number of vehicles on the Limehouse 22 Sideroad route which involved more children. There are 40 children from Limehouse who don't even have a bus, he said, and must cross the road four times during the day on the way to

and from school. "Now where is the most dangerous place?" he asked the delegation "22 or 17?"

Backs reeve up

Councillor Marshall backed up the reeve with figures from a personal survey he made although he told ratepayers he found very few trucks on either road when he visited on a recent afternoon. He opposed changing the route along with the reeve who said introduction of

more truck traffic on 25 Highway could raise the ire of provincial highway authorities.

Both the reeve and Mr. Marshall suggested ratepayers who thought council was doing them an injustice could show their displeasure at

the ballot boxes in the next election. Frank Holtman of Limehouse suggested perhaps the route could be changed to the Fourth Line to 7 Highway if the council opposed using

the 25 Highway route and then asked why the quarries could not build their own roads like they do in Northern Ontario. Indusmin representative Jim Kerr answered the first part of Mr. Holtman's question by listing the reconstruction of 7 Highway as the

reason trucks could not take the Fourth Line route. He defended the role of the quarries in the present controversy, referring to the long (Continued on Page 3)
