



# Election in Eramosa township

township increasingly progressed under the leadership and updated thinking of Mr. Lush. "Five years is long enough as a council member said Mr. McPhedran "And I have decided to let my name stand. I will serve for another two years for Eramosa and will run for deputy-reeve."

He said that, although he had never been interested in working for the county council he had decided, "If you can't beat them, join them" and with that Mr. McPhedran professed intention to join county council. He paid tribute to the fire chief, Carl Meadows, whom he said. showed special abilities in planning efficiency in the township fire hall which is presently being built in Rock-

Mr. McPhedran indicated his own special knowledge regarding the Wellington County Board of Education and, in weighing the smaller school board systems felt that he would like to see more reasonable spending in certain luxury items.

"At one time" said Mr. Mc-Phedran, "a caretaker put in a glass window but now, with the present system it costs the taxpayers \$20 to repair it". He said that the county school board prizes itself on having an adequate staff on all schools throughout the county, "but," said Mr. McPhedran, "If the principal were given a free hand on running schools and allowed to set up his own budget it would cost us less money.'

Mr. McPhedran had many new attitudes which he thought should also be considered by the

Ratepayers' Association for the future as an answer in being prepared for the long range expectancy of regional planning.

Stand for reeve Warren Parkinson, who is presently a council member, said he would let his name stand for reeve and in his 10 minute speech allotment referred to the various accomplishments of township council. He spoke highly on the efficiency of the Eramosa Fire Department and said that, because it is composed of volunteer firemen it is an economical function in the entire township. He also mentioned the \$70,000 mystery debt Eramosa council had found itself faced with after the Wellington County Board of Education went into power and which, hopefully can be spread over three years. He touched on several problems which had evolved and said that although he had voted against the industrial waste plant he really couldn't say whether it was right or wrong.

"Sometime in the future we are going to be faced with the problem." He said he was sorry that Cam Lush was leaving and that he (Mr. Lush) was leaving big shoes to fill, and in his own case he would let his name stand.

Bill Adsett spoke next, giving a summary of his contributions as a council member. "I became a councillor three years ago" he said "and if I were a ratepayer I would like to think that there would be some proof of action in three years". He said that the' first year he had asked questions and listened, using his judgment and voting as he saw fit.

His resume of performances indicated over his years of office Mr. Adsett has progressed knowledge of recreation requirements and is interested in promoting tourism in the area. He was recently asked to become a director on the Board of region and he has served some time as a delegate of the Mid-
