Organize minor lacrosse

Acton Rams' junior lacrosse club will be charged \$4 an hour for use of the community centre for games and practices this summer, it was decided at Thursday night's regular meeting of Acton Parks and Recreation Committee.

The \$4 figure, which represents a one dollar charge decrease over last year, was suggested by committee member Barry Inscoe and unanimously approved by all other members.

Minor teams Ram Howard Dwyer and team manager Alan Hall told the committee, they hope to enter a juvenile team in addition to a Jr. C. Club in the Ontario Minor Lacrosse Association for the first time this year. They will also organize three house league teams, one tyke, one peewee and one bantam which will likely play in an Oakville house league. Mr. Hall explained the junior team will act as a parent club for the juveniles and house league teams. He said he hopes the junior team will be able to support itself on gates.

"I'd like to see the hourly rate dropped to \$4, since they're starting a minor system at no cost to us," Mr. Inscoe explained. It was Mr. Inscoe's opinion \$4 an would more than compensate for any charges such as hydro incurred by the committee as a result of the team's use of arena facilities.

He predicted gates for junior games will increase this year and the juniors would probably be able to partially subsidize minor

"They're a very responsible party," he said "They leave the arena neat and tidy. If we had

more parties as responsible our lob would be a lot easier," he

Councillor Peter Marks suggested the committee work on a 50-50 gate split with the juveniles who will probably play home games Friday nights. " we find the committee's receiving execessive revenue we

can alter it," he said. All members backed Mr. Marks' suggestion that floor time for the house league teams be provided free of charge.

Tentative arrangements have the junior team playing home games Monday night, and practicing Sunday mornings, the juvenile team playing Friday night and practicing Sunday mornings and house league teams playing either Tuesday nights or Saturday mornings.

Fees high With referees fees so high, Mr. Dwyer told the committee the

junior team was lucky to make a \$4 profit from a game that drew 200 people last year.

The committee also agreed to purchase new mesh for the lacross's goal nets at a cost not to exceed \$75 and granted the team permission to use dressing room number one with its additional storage room facilities and erect a team booster sign in the arena

Decision was reserved on a request that the committee sell lacrosse sticks from the arena booth, Mr. Marks felt the committee should investigate to make sure they weren't competing against local merchants in the sale of sticks.

Hockey sticks are sold from the booth, but Mr. Marks explained that is done for the sake of convenience since hockey sticks are easily broken.

Will repair arena

Acton Parks and Recreation Committee hopes to have another \$13,000 worth of necessary repairs done on the arena this year.

At Thursday night's meeting, chairman Hugh Patterson reported the committee will go ahead with things specified in a Dalton Engineering report, namely repairs to the east and west walls (the ends of the building).

Another \$13,000 worth of repairs to the north wall will have to wait until next year.

"It's the real guts' issues we're dealing with," councillor Peter Marks commented.

"Basically we'll try to bring the roof back up so its straight" said councillor Orval Chapman.

Repairs to the south wall, done last summer, cost \$8,000 including engineering fees.
