Oppose hydro line

5,000 names on petition

Although they have achieved their target of 5,000 names, the Coalition of Concerned Citizens (CCC) decided to continue petition name gathering until they can present their brief to Premier William Davis, hopefully sometime in March.

This was decided last Thursday night at a meeting in Snelgrove where the group met to review their plans for opposition to the proposed 5,000,000 transmission line which Ontarlo Hydro proposes to build from

Pickering, east of Toronto, to Nanticoke on Lake Erie. The line would affect the southern portions of Erin and Eramosa townships and the northern part of Nassagaweya.

Sixty representatives from most of the 10 townships along the route attended the Snelgrove meeting. Lee Symmes of Terra Cotta acted as chairman with Mrs. Audrey Symmes as secretary.

Protesters are also writing letters to Queens Park about the line and several indicated they

have received replies. Encouraged by Hydro

The group was encouraged by Ontario Hydro's attitude as expressed last week in a desire to meet with various councils, representative citizens and spokesmen for environmental groups to discuss the issues of the transmission line. Chinquacousy reeve Robert Williams said Hydro is now furnishing the information required to study the

Although Ontario Hydro has

said the line is essential if the people of Ontario are to have electrical energy to support economic growth in the seventies, the chairman George Gathercole has also said the Commission does not have to be rigid regarding the exact route of the line which will blot out several homes in this area.

The CCC group intends to approach the various township councils to ensure they are aware of the latest Hydro offer and have the opportunity to review the situation with objectors.

Annexation push again

Acting on Mayor Les Duby's warning that "perhaps this is our last hope to determine things for ourselves," planning board last Thursday agreed to again push for annexation of land from Esquesing township for the town.

The mayor brought to the board the latest word on annexation from provinctal treasurer Darcy McKeoughthere's no decision on Halton-Peel regional government yet.

Mr. McKeough indicated to the mayor that regional government is imminent for Kitchener-Waterloo and Sudbury, but not this area yet.

Mr. Duby was meeting with the cabinet Wednesday as part of the delegation of the Association of Ontario Mayors and Reeves.


