Two new councillors capture Eramosa seats

Former deputy Jim Milne and Eramosa's first lady challenger for a council seat, Betty Lou Clark ran solidly behind the township's top vote catcher, incumbent Bill Adsett, to Capture seats on Eramosa township council Monday. Incumbent Ken Fair and challengers John Hewitt and George Majors were defeated.

In the two way race for deputy-reeve, the present deputy Duncan McPhedran, scored a 610-375 victory over challenger Don Gordon, while Rockwood's George Day took a 149 vote margin over Jack Gilchrist to take the one Board of Education seat shared by Guelph and Eramosa townships.

Sitting councillor Bill Adsett run strongly in all polls to rack up 667 votes while his nearest competitor Jim Milne came in second with 562 votes with strong votes in Rockwood and Eden

lear mandate

Betty Lou Clark, who smashed the male dominated township council for the first time in history, trailed incumbent Ken Fair and John Hewitt until the results from Eden Mills gave her a clear mandate and the third scut on council with 424 votes. It was her first attempt to gain

John Hewitt trailed Mrs. Clark by 34 votes and he was followed by Councillor Ken Fair who was eight votes behind Hewitt. George Major, a first time challenger, trailed the field with

The future looked bleak for George Day when results from Guelph township were tabulated giving Jack Gilchrist a commanding 358 to 44 lead in the race for Board of Education, but George recovered and went on to put a 782 to 633 victory. The winner showed strong support in Rockwood and area.

Eden Mills

At Eden Mills, Harold Tomlinson, David Masson and Rodney Bell shared a close race knocking Harry Schelke out of the race for the three trustee seats. Tomlinson led the polls with 113, Masson received 103 votes and Bell got 87. Schelke trailed with 43.

Results showed that 21 out of 22 who voted at Eden House cast bullots for Betty Lou Clark in the six way race for three council sents. Mrs. Clark also ran strongly in Eden Mills where she outdistanced competitors with 135 votes, closely followed by Jim Milne with 102. The rest were well

Contentious issue The results seemed to indicate that the contentious water and sewer proposals in Rockwood had a bearing on the vote in Eden Mills, which is down-river from the proposed water pollution

control plant. Despite the inclement weather most of the candidates and a few supporters waited patiently at the municipal offices on 24 Highway for results to arrive. First returns from polls four, five and six were in early after polls closed but counting at Rockwood and Eden Mills was slower and it was almost 12.45 a.m. before the close council race was decided.

Candidates who earlier were very much in the running were allocated to the also-rans when the Rockwood and Eden Mills ballots arrived.

Parties or bed

The crowd at the township offices broke up quickly when the totals were counted, some going to victory parties and others just home to bed.

Although final figures were not tabulated when the Free Press went to bed, Returning officer 1 loyd Hindley estimated about 32 per cent of the eligible voters in the township exercised their franchise. The bad weather settled over the township during the day obviously cut the number of voters down and also reduced numbers of interested people at the election headquarters.

Say "Yes" to beer, liquor but only liquor legal

· Electors in Eramosa township gave a majority of votes to the "Yes" column for both the sale of beer and wine and liquor under dining room licences. However, only the sale of liquor has the required 60 per cent majority to make it legal.

Voters endorsed the sale of liquor in the township by 631 votes to 350, which is 64.9 per cent of the total figure.

The sale of beer and wine received less enthusiastic boost, however, with 567 approving and 409 opposed, or 58.7 percent - 1.3 percent less than the 60 required.

Figures show the majority of those opposed to the liquor and beer questions came from the northern end of the township. Those in the Rockwood and Eden Mills areas endorsed both questions by larger majorities.

The liquor vote came as a result of a petition from electors in the township requesting a plebiscite. It was mandatory for council to put the question on the ballot.

Bateman heads Rockwood poll

Monday's election scene in Rockwood was a battle between the tried and true and newcomers who had special attitudes on what they would like to see for the village future.

All four candidates had the opportunity to present their platforms on the previous Wednesday's Candidates' Night and had conveyed their thinking that Rockwood's growth should be slow and kept within present boundaries.

Water and sewer installations and regional government were the main issues. All four men were in agreement that regional government would not benefit the village. Regarding the water and sewer issue they also felt that further investigation as to lower From the first ballot,

newcomer Gary Bateman with the total 276 votes, former trustee Bob Leslie with 232, Bert Smith, incumbent, with 203 and Ralph Kelly went out with a 185 - a close election.

Mrs. Bell said that, "For those parents who cannot take advantage of such a facility we are sorry that it is not possible to continue its operation as it has been such a wonderful training period for the children in other years". Accordingly nursery schools must be operated with specially trained teachers with a required number of children participating and adequate toys and facilities available according to departmental requirements.


Executive During the meeting secretary Jean Reinhart gave her report


