Sheridan takes over Credit Valley nursing residence

Sheridan College has been given the 10-storey Credit Valley School of Nursing residence by the provincial ministries of health and colleges and universities.

The two ministries, which have turned over nursing education to the community colleges (as of Sept. 1), announced that all community colleges that take over regional schools of nursing will also take over the buildings belonging to them.

Credit Valley, with two floors of classrooms, is considered a regional school in that student nurses take their courses outside a hospital in a separate building.

The remaining eight floors at Credit Valley comprise the student nurses' residence and after the expected 235 nurses arrive in September there will be room for between 50 and 100 other students.

Both male and female students who want to live at Credit Valley this fall can apply at the Student Services housing bureau at the Oakville Campus or at Credit Valley.

Credit Valley School of Nursing, which opened in 1969, is located on Hurontario Street in Mississauga south of the Queensway.

The task force assigned to complete details of the arrangements between Sheridan and Credit Valley had already decided to give the building to nearby Mississauga Hospital when the provincial

ruling came down.

Following the government's decision to link nursing education with the community college system, college president John M. Porter said the change would end the isolation of nursing students from all post-secondary students.

The college looks forward to the integration of programs and students at the two campuses. Plans are under way to hold adult extension courses in the evening at Credit Valley.

Sheridan College has one other student residence at the School of Design in Mississauga which is used by students taking three-year arts and crafts programs.

Government aids students

Here is an important announcement concerning 'A Definition in the Ontario Student Awards Program which could provide students with additional financial assistance if they have a total of three years post-secondary and/or work experience.

Modified Group A—If prior to the first day of the month of official registration for the academic year for which you are requesting financial assistance, you have completed at least three successful years of study at an eligible post-secondary institution or have a combination of successful academic years and periods of 12 consecutive months' employment totalling three years, you will be assessed as a Modified Group A student with an additional sum allowed as a deduction from parental gross income.

This could result in a much lower or even a nil contribution from the parents.

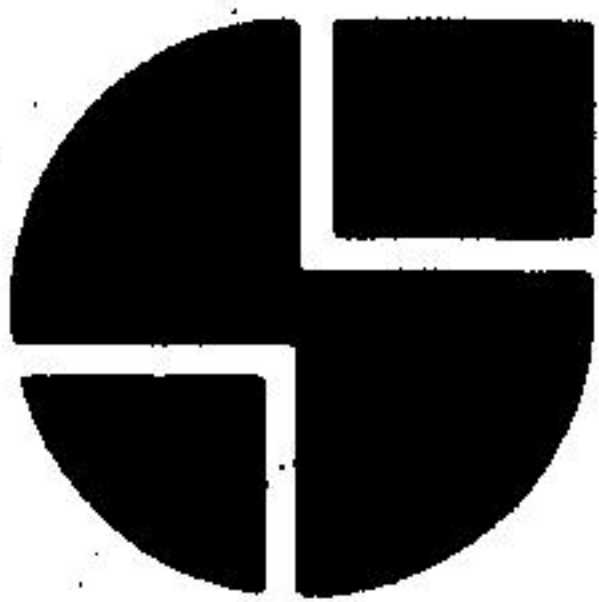

Employers come to Sheridan

In May 1973, approximately 850 students graduated from Sheridan College. Some are travelling or preparing for further studies, but the majority have now entered the work force.

Throughout the year the Student Services Department has been active in putting graduating students in direct contact with employers. From January until May 1973, 56 companies visited Sheridan College to conduct "on-campus" interviews for permanent employment. Permanent, part-time and summer employment opportunities are posted in the student service office throughout the year. In May, students who are seeking employment, register with the office and are notified by phone when a job opportunity related to their field of training is available.

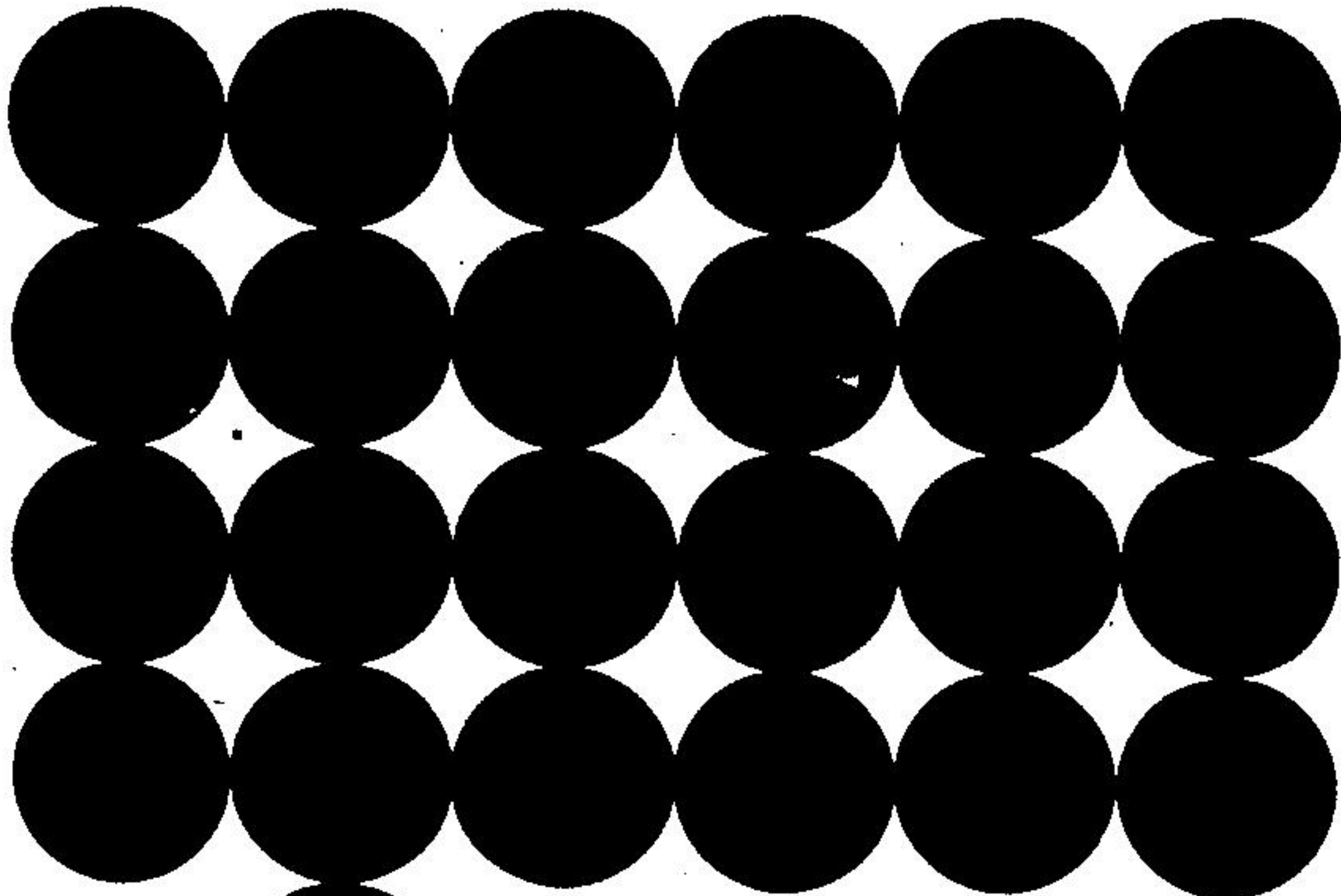
Many graduates have taken advantage of this service and have been successful in finding suitable employment.
