Interested Citizens push for independent line study

Chairman of the Interested Citizens Group Bill Mann claims Dennis Timbrell in his news release concerning the proposed Bradley-Georgetown transmission line misrepresented the true facts by saying this study was in response to complaints of residents in the area, inferring that he was giving the citizens exactly what they had asked for.

Mr. Mann, replying this week to the Environmental Hearing Board report, goes on to say the Interested Citizens Group he heads has never asked for a study of the restricted area between Points 33 and 95, but have always requested an independent study of the total corridor.

"The first request was as early as July 1973," he says. "This point was confirmed in the Environmental Hearing Board report where it was noted that not one citizen, organization or group opposed the decision taken by the Independent Citizens

of Energy, released the report by the Environmental Hearing board relative to the proposed Bradley-Georgetown transmission line last week. The report was the result of a series of meetings held from July 15, 1975 to August 7, 1975, at Hillsburgh on a restricted portion of the alter the Board's term of proposed line.

"It is gratifying to learn that the Environmental Hearing Board in their report confirmed the Interested Citizens" Group's long-term contention that there were other alternative routes outside the study area which would transmit 500kV power from the Bruce Generating Station to the 500kV grid system," says Mr. Mann.

Contention "It is the Interested Citizens' Group's contention and evidence was given in this regard that a shorter, more direct route is available with

"We've been had" on hydro corridor - Reed

Energy Minister Dennis Timbrell has been accused of disregarding the serious concern shown by Mr. Caverly and and the Environmental Hearing Board over the difference of opinion between Ontario Hydro at such an advanced stage of the decision-making process over the proposed Bradley Junction to Georgetown hydro corridor. .-

In a press release this week, Julian Reed, MPP for Halton-Burlington, said the concern expressed by the Interested Citizens has not had a public forum because the Ministry of Energy has disaflowed their debate. "Until their case is properly heard, this whole procedure will be nothing more than sham", Reed said. "Unless hearings of this kind are conducted in the early stages before money and time are committed to such projects, we will be doing no more than paying lip service to public participation."

Reed noted Mr. Timbrell had given approval to Hydro to begin work on sections of the line between Bradley Junction and Colbeck and between Limehouse and the Milton transformer station in spite of repeated requests from concerned citizens for a totally independent study based on premises never allowed consideration or debated at the hearings in Hillsburgh conducted by the Environmental Hearing Board. The Halton-Burlington MPP said the energy minister also has not taken into account the Premier's request to former Minister of Agriculture Bill Stewart to look into the matter, and "whose reply has not been forthcoming."
