

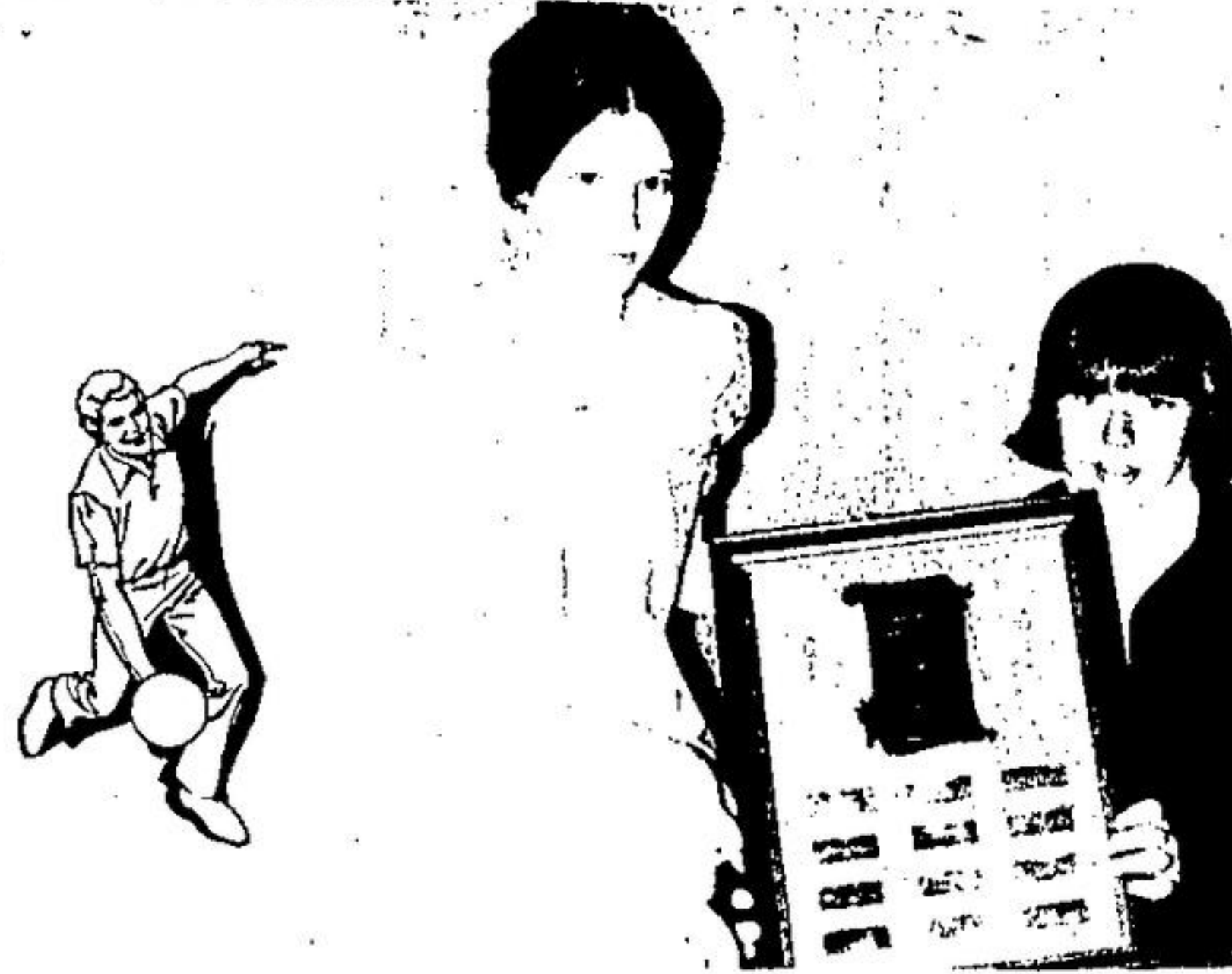

Commerce Term Deposits.

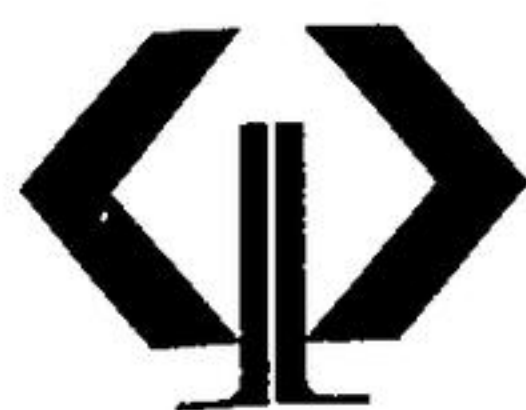
Here's how they work. Currently if you invest for any period of over one year to six years the rate is 9¹/₂%.

Say you put in \$1,000. (You can't put in less). If you left it in for a year and a day, you'd get 9¹/₂% interest.

Interest varies according to the term of the deposit and is paid on April 30th and October 31st.

If you cash it before maturity, there is an interest penalty. It pays to be patient.
