One vote per person


A person can only vote once in the municipal election even if they own or rent property in all of Halton Hills four wards.

Returning officer Doug Pritchard says that if a sold in Canada person lives in one ward but also rents or owns land in another ward that person must vote in the ward in which they reside.

At the same time if a person doesn't live in Halton Hills but has property in more than one ward he can arrange through the town clerk's office to vote in the ward of his choice.

Nov. 10-15 Nomination papers for the upcoming municipal and school board elections can be filed with the returning of-Doug Pritchard, Wednesday, beginning November 10 until Monday,

November 15. In an interview Pritchard said notices will be published in local papers "calling citizens to nominate people for office" on November 3 and noted nomination forms are

already available. On November 10, 11 and 12 nomination papers may be turned in at the Halton Hills administration Seventh Line, between the hours of 8:30 a.m. and 4:30 p.m. while the office will open at the sa same time but close a half hour later the last day for nominations on November

He noted a candidate must make sure his or her name is on the final list of voters to be elegible for nomination and each of the 10 residents who sign the nomination form must also be on the list.

Pritchard encourages all condidates to turn in their nomination forms as early as possible after the nominating period begins so that if there is a mistake they can be notified and have it rectified forms are available now his office can not accept them until November 10.

Candidates who are nominated for more than one office then have until 5 p.m. to withdraw all or all but one of the nominations. If a person doesn't appear at the municipal office to specify which of any offices he or she is funning for the office for which the person was first nominated for will be the one which they are standing for.

He noted the list of nominations will be posted at 5 p.m. November 15 at the municipal office and then revised again at 5 p.m. on November 16.

RESTORATION OF Avenue, on the Esquesing GEORGETOWN MEMORIAL ARENA

Last winter the Provincial Government issued new regulations and changes in the Building Code as it pertained to public institutes, arenas and community centres. On close investigation of the Georgetown Memorial Arena, it was found that structurally it was deficient in some areas due to metal stress and fatigue, and wood deterioration. Consequently, it was closed for a full investigation and for the protection of the users.

Recently, the Treasurer of Ontario announced that an additional Assistance Grant from Winterlo funds would be available to all municipalities who had closed their arenas because of the above Building Code changes.

However, in order that the Town of Halton Hills could avail themselves of this grant, they must abide by the stipulation contained in the grant that 25 per cent of the cost of renovation must come from public subscription and not from taxation. The following is a brief breakdown of a plan to comply with the stipulation:

Sources of Revenue

\$50,000 00 a) Community Centre Grants

b) Contributions by Public Organizations 50,458.00

c) Wintario Grants

d) Town operating budget and reserve

thus the amount to be raised by Public Subscription is, as stated above, \$50,458.00. As you can see by participation in this Assistance Programme, the municipality can effect a saving of \$92,292.00 which, directly or indirectly, has an affect on the

once again become functional at a minimum of cost. Participation in the raising of the required amount of \$50,458.00 can take the form of a pledge to pay a specified amount over a period of three (3) years, or an outright donation of a specific amount.

We are not unaware of the contributions that all organizations give to our community and know that your response to our request for assistance at this time will enable our Town to take advantage of this opportunity to be of further assistance to our fellow citizens.


