Three seek re-election, two undecided

Eramosa township council faces an election in December. Most members have made their decision whether

to run again, a few have not. The Free Press polled the council members and discovered, not surprisingly, the Rockwood sewer and water project is considered by all to be one of the major issues of the past two year term.



Reeve Bill Adsett will seek re-election

The veteran Eramosa township council, Reeve Bill Adsett has decided he will run for the same position in the upcoming municipal election.

Mr. Adsett's political career began in 1968 when he became interested in what was happening locally. At that time he began to think that if he was going to have things to say he should "put

up or shut up". He ran for a seat on council which he held until 1974, when elected reeve.

Because all affairs were handled as committee of the whole he did not sit on any specific committees. He was involved in recreation and the now defunct Mid Western Tourist council.

As reeve, he automatically sat on the Wellington county council. It was here that he was placed on the finance committee, administration -committee, and planning and development committee. He is also on the Guelph General Hospital Board, and the Guelph and Suburban Planning Board.

As reeve of Eramosa township, he is an ex-officio member of all committees formed by that council.

As for the past two years, Mr. Adsett said that it was the time for many major items to come to a head. As examples he mentioned the sewer and water project in Rockwood, the zoning by-law, and municipal drains and the community recreation complex. He explained that none of these ideas is completely resolved.

Belty Lou Clark As Deputy Reeve of the township, Betty Lou Clark has been busy on the county council and on several committees. However, all this has not deterred her, and she plans to run in the December

Mrs. Clark is finishing her fourth year in politics. She sat on council for two years before deciding to run as

Deputy Reave. Her present position automatically places her on Wellington County

As deputy reeve, she sits on the recreation committee, the local advisory committee for architectural conservancy, and the finance committee.

Mrs. Clark is the chairman of the Pioneer Cemetery committee, and chairman of Social Services committee for Guelph and Wellington county. She is also a member of the agriculture and community committee, community services committee. She is a board member on the VON, the Eramosa library board and is a member of the

constituency advisory group for Local Initiative Programs. She is also a member of the board of directors of the Children's Aid.

Five years ago, when sewers and water in Rockwood were only proposals, the ratepayers in that area approached Mrs. Clark, who belonged to the ratepayers association, and suggested a pipeline to Guelph, if the project was passed. It was Mrs. Clark as deputy reeve, who mentioned it to council five years later, with the proposal eventually being accepted.

"I feel I have made a sincere attempt at listening to what the taxpayers are saying," Mrs. Clark said. She continued to say that she does her best to listen to what the people are saying. She explained that as a taxpayer, she felt frustration when dealing with councillors and does not want people to experience that.

Mrs. Clark stated that her main concern is the continuing loss of agricultural land in the township, something which she has opposed for the past few years.

If she is re-elected, Mrs. Clark will not be sitting on county council again, as the deputy reeves have been eliminated from that seat. She said she was the only deputy reeve to vote for the elimination as she felt the reeve should have the voting power.

Mrs. Clark is a real estate agent with United Trust in Guelph. She is very active in community services and is an alternative for the Synnott in diocese for the Anglican

Mrs. Clark began her busy career after her three children had grown. "I started at home and was a mother first and foremost. I had the energy within me tafter the children had grown) and used it constructively."

The councillor began in politics after he retired as a construction manager in London. He moved to Fergus, where he was asked to be building inspector. After two years, he was forced to resign when his wife took sick. After a while, the township asked him to sit on the Fergus high school board which he did for three years. He was also on the Fergus hospital board.

After his stint there, he ran for council, but was defeated by Bill Adsett by 24 votes. He ran again a few years later. and was defeated by Betty Lou Clark by ten votes, he


From 1970 until 1972, Mr. Hewitt sat on the Eramosa planning board, and resigned to run for council.

Councillor David Masson has not yet decided whether he will be seeking re-election. Mr. Masson explained to the Free Press that he has

just accepted a job with Lear-Slegler in Kitchener as production control manager after 17 years at Ford Motor Company in Oakville. He does not start his job until this Monday and therefore does not know what commitments he will have to make with the new firm.

The Eden Mills resident began his political career almost six years ago as a trustee with that village. After four years, he decided to take one more step up the ladder and run for township council

Once he was elected as councillor, Mr. Masson was assigned to sit on the finance and personnel committee, on which he was appointed chairman, and the recreation committee. He was also on the steering committee for the Rockmosa Sports Com-

Mr. Masson explained that he enjoyed his time on council and "I like to think we accomplished something." He sald there is a lot of personal satisfaction. "Council as a whole worked very hard to keep municipal taxes down." Mr. Masson went on to say that he thought the quality of services in the Eramosa area

was very good. His greatest reward in his political career was that of lobbying to get the Nassagaweya portion of Eden Mills into Eramosa township, and the rerouting of the fourth line. "When you start something like this and see it through, it is very reward-

Mr. Masson explained that even though he lost his debate on the Rockwood sewer and

water issue, the voted against it), he dld not try to stall it, but pushed for a pipeline for the sewage to go Guelph to help save the Eramosa River.

The councillor admitted that he learned a lot sitting on council, but he also felt the council learned a lot from him. He explained that because of his involvement with industry, he was able to offer various viewpoints on matters. "It is a two way street." He explained he received a lot of personal satisfaction from the two year experience, but at the same time feels he contributed equal amounts.

"You get out of it what you put into it," he concluded.

By-law discussed

at public meeting

The events, advertised once in local weekly and daily papers; was for the purpose of presenting the long awaited Restricted Area Zoning bylaw which Eramosa Planning Board and Council, with input from Rockwood and Eden Mills, had worked on for some

Guess chairman Campbell of many years municipal planning experience in Fergus introduced Bill Lehman of Dryden, Smith & Lehman, Planning Consultants of Kitchener, Mr. Lehman, who had guided Planning Board and subsequently written the document reflecting the board's opinions read a summary of the by-law and answered questions from the floor. Copies of the summary handed out at the meeting had also been advertised as available to the public in the 'ownship clerk's office and he complete by-law was available to be read at the

same office. Those who attended were welcomed by Reeve Bill Adsett at the outset and commended for their interest in community affairs. It was stressed that the by-law pertained to all residents of the municipality and regret was expressed that so few had appeared. This was a recurring theme by other speakers

of the evening. Questions from the floor dealt chiefly with the areas of Hazard Lands, the Agricultural Code of Practice, Pits and Quarries, definition of a serviced lot, and offices in homes. Persons with concern were invited to send same in writing to the township clerk by October 15. Mr. Lehman promised the meeting that these would be duly considered by council and Planning Board. He further ex-

plained the procedure to follow. A final summary would be created and copies mailed to all ratepayers. If ratepayers then have objections they should forward them in writing to the township clerk. These letters will subsequently be forwarded to the Ontario Municipal Board and a hearing could be held on decision of the Board. Once approved by the Board the document becomes law replacing the existing by-law.

Eramosa Council had called the meeting in order to afford citizens an apportunity for their input.

The Planning Consultant, Mr. Lehman stated to the reeve who was expressing concern privately about the limited response, "you have already gone the second mile. You have held a public meeting which is not mandatory. The people still have the opportunity to object." The procedure for same has been outlined in this article.
