





Authority defends land acquisition non-use of sensitive ecological areas

"Man is the environment's worst enemy. Unrestrained, he used ecologically sensitive areas as his stampingground, then wonders what happened to the green, open space he used to enjoy."

This was the answer by a CVCA spokesman to a recent question, "Why is the Credit Valley Conservation Authority buying all this land in the watershed?" The question was raised following a recent illustrated talk.

Several of the areas shown and described are not readily available to the general public and this raised a question in the minds of the audience.

The Authority owns approximately 5,000 acres in the Credit watershed. Multipleuse conservation areas (i.e. Terra Cotta, Belfountain, Meadowvale, Monora) comprise about 1,000 acres open to the public as recreation areas, but also provide an insight into forest and water

management, preservation of historical sites and a showcase for good conservation techniques. The cost of providing services for people is high and a great deal of planning must be done before development begin.

In the Orangeville Reservoir Conservation Area the 450 acre lake is surrounded by another 400 acres of forest, meadow, and marsh which is gradually being developed into a multiple-use area with emphasis on the educational aspects that the area pro-

are not open to the public because they are primarily fire-prone coniferous growth. The 750 acres contribute to the water holding capacity of the Caledon hills which could be susceptible to erosion.

Included are the headwater Caledon Lake. Swamps may

not look attractive but they serve as water retention areas which act as sponges when precipitation is high and allow slow drainage into streams and the Credit River. Wetlands are also preserved intitial phases of park at Orangeville Reservoir, in several of the forest areas, at Terra Cotta and Silver Creek

Conservation Areas.

Protection of environmentally sensitive areas has been a prime factor in the purchase of much of the Niagara Escarpment lands in the past five years. Previous to this 200 acres were purchased at Limehouse but not Forest Conservation Areas developed for masses of people because of the sensitive nature of the area. It was found, when further studies were made, that the project was not environmentally feasible and that this unique area should be protected. At the present time, an ecological study has been completed and a Master Plan for development is in

Floodplain is the space on either side of a river which is susceptible to flooding during a heavy storm. Floodplain management and acquisition are major projects of the Credit Valley Conservation Authority. Floodplain lands along the

Credit River owned by the Authority include several large areas, primarily in Mississauga, where the pressures of development have made the acquisition of these lands imperative. Small par-

land previously acquired are, in several cases, leased back to the City of Mississauga for parks development.

Building, filling or alteration of watercourses on floodplains are regulated by legislation enforced by the Authority.

Acquisition of land along the Mississauga Waterfront of Lake Ontario has been, in some cases, instituted at the request of the City of Mississauga. The approximately 125 acres is tied into an overall Waterfront Plan. The first five years of the 15 year plan have been completed and work is progressing on the second five year phase. Land acquisition along the lake has necessarily been costly but public access to Lake Ontario is of prime importance in a

major urban area. Land acquisition has included property from north of Orangeville, west along the

Escarpment and south to Lake Ontario. As land becomes available and budget permits, further purchases may be deemed feasible, an Authority spokes-

Urban development is accelerating as each year passes and small towns in the watershed are expanding rapidly.

The Authority feels it is imperative land be purchased when available, for it may never be available again. The Conservation Authority is preparing for future generations in the Credit River Watershed by providing green, open space for quiet relaxation and conservation education. An appreciation of trees, plants and clean water sometimes has to be learned and access must be preserved in an ever growing, polluted and noisy world, the Authority feels.
