A by-law to amend By-law 1358, as amended, of the former Town of Acton, now the Corporation of the Town of Halton

WHEREAS the Council for the Corporation of the Town of

Halton Hills deems it necessary and advisable to amend By-law 1358, as amended. NOW, THEREFORE, THE COUNCIL OF THE CORPOR-ATION OF THE TOWN OF HALTON HILLS ENACTS AS

FOLLOWS: 1. Schedule "A" to By-law 1358 is amended by changing the zone designation of those lands outlined on the plan attached to this by-law as Schedule "1" from R3 (Residential Third Density) to R3-1 (Residential Third Density Special).

2. Notwithstanding any provisions of By-law 1358, as amended, to the contrary, the lands known as Lot 21. Registered Plan 98 in the Town of Halton Hills (formerly the Town of Acton), may be used for no purposes other than a two storey semi-detached dwelling in accordance with the site plan attached to this by-law as Schedule "2".

. 3. This by-law shall take effect on the day it is passed by the Council of the Town of Halton Hills, subject to the approval of the Ontario Municipal Board.


