



LIMEHOUSE CLIFFS, south of Limehouse, takes in most of land owned by the Credit Valley Conservation Authority and is considered an area of historic and environmental importance.



WATERFALL PARK situated north east of Limehouse is a large environmentally sensitive area through which runs the Bruce Trail.

Environmentally sensitive areas

Woods, cliffs shelter rare plants and birds

This is the second in a series of reports on environmentally sensitive areas based on a prepared report from Halton region.

WATERFALL WOODS
Waterfall Woods is composed of two woodlot communities situated south of Highway 7 reaching the Fifth, Sixth and Seventh Lines and extending as far south as the 17th Street.

Consisting of the Niagara Escarpment, a deep valley, small ponds and marshes, the woods feature sugar maple, white cedar, yellow birch, ash, red maple, eastern hemlock and tamarack.

Rare plants in the area include big Twayblade and black walnut. Significant plants include white adders mouth, beech drops, oak fern, larch, three-leaved false Solomon's seal.

Bird sightings feature northern waterthrush, turkey vulture, black-billed cuckoo, and white-throated sparrow.

The report recommends that rural estate development in the area should be limited commenting the site seems relatively undisturbed at the moment except for some estate development on the Fifth Line, an unused quarry east of the Sixth Line and a

trailer park near it.

LIMEHOUSE CLIFFS AND WOODS
Located south of Limehouse between the Fifth and Sixth Lines, this property, partly owned by the Credit Valley Conservation Authority, is located along the ravine of the Black Creek. The steep valley sides are forested by sugar maple, ash, beech, pine and hemlock. Fissured rocks of the Escarp-

ment shelter fragile plants and historical artifacts, lime kiln remains and an old mill are located here.

Ten species of ferns, some rare or unusual, are sheltered here. The Black Creek running through the area is noted for its brook trout. Significant plants include the rare walking fern, and maidenhair spleenwort. Unusual plants noted are common polypody, fragile

fern, nightflowering catchfly, carrion flower, shinleaf, buckthorn and black ash.

Birds present featured black-and-white warbler, read-headed woodpecker, and winter wren.

The report recommends public acquisition of remaining lands not owned by the Credit Valley Conservation Authority to reduce possibility of rural estate development.

School hours policy

Halton board of education will soon be dealing with the issue of school hours.

Currently schools set their own hours and openings and closings may vary from about 8:20 a.m. to about 2:30 p.m.

Emerson Lavender, director of education, told the board Thursday that a joint committee of elementary and secondary school teachers would have a report on the matter in the near future.

Lavender said some schools cannot operate on the same lunch hours as other schools and that there are rational reasons for the different times.

Another question to be considered is the effect on

parents who have children in three different schools, each with different hours, Lavender added.

Trustee H. H. (Bert) Hinton said that instead of a "hard line policy" the school principal with the police traffic officer and the administration should resolve the matter.

Trustee Judy Alexander said that the board is losing sight of its job of setting policy and is dealing with administrative matters.

A motion by trustee Len Crozier that the board establish the hours for both elementary and secondary school was tabled.

TOWNSHIP OF ERAMOSIA NOMINATIONS

Notice is hereby given to the Municipal Electors of the Township of Eramosa in the County of Wellington that the period during which nomination papers may be filed in the office of the clerk for the purpose of municipal elections will commence on Monday, October 16, 1978, to Monday, October 23, 1978, during normal office hours - 9:00 a.m. to 5:00 p.m., a nomination paper in the prescribed form for the offices (s) of: Reeve, Deputy-Reeve and Councillors for the Township of Eramosa Trustees for the Police Village of Eden Mills Trustees for the Police Village of Rockwood Member to represent the Townships of Eramosa and Guelph on the Wellington County Board of Education of which all Electors are hereby required to take notice and govern themselves accordingly; and further take notice that the manner in which said nominations shall be filed is set forth in section 36 of The Municipal Elections Act which provide that:

How nominated

36 (1) A person may be nominated as a candidate for an office by filing in the office of the clerk, during the normal office hours of the clerk within the period in which nominations may be filed, a nomination paper in prescribed form which:

- (a) shall be signed by at least ten electors whose names are entered in the polling lists of electors entitled to vote in an election to such office.
- (b) shall state the name, occupation and address of the person nominated in such manner as will identify him and the office for which he is nominated, and
- (c) shall state the name and address of each elector signing the nomination paper and, where the office for which the person is nominated is a member of a school board, that such nominator is a public school elector or a separate school elector as the fact is. 1974, s 20 (1).

Consent and declaration to be filed

(2) No nomination is valid unless there is filed with the nomination paper a consent in writing to the nomination and a declaration of qualification in the prescribed form by the person nominated.

Public School nominators

(3) A nomination paper nominating a person for an office the holder of which is required to be elected by public school electors shall be signed by public school electors only. 1974 s 20 (2).

Separate School nominators

(4) A nomination paper nominating a person for an office the holder of which is required to be elected by separate school electors shall be signed by separate school electors only. 1974 s 20 (3).

Separate Nomination papers

(5) Each candidate for election to an office shall be nominated by a separate nomination paper, but an elector may sign the nomination papers of different candidates.

Clerk to keep nomination paper

(6) After a nomination paper is filed with the clerk it shall remain in the possession of the clerk.

Onus on person nominated

(7) The onus is on the person nominated for election to an office to file a bona fide nomination paper.

If a greater number of candidates than required to fill the said offices, are nominated and make the required declarations, notice of the time for the holding of the poll, including the advance poll and notice of the last day for making applications for a certificate to vote by proxy will be given forthwith. THE LIQUOR LICENCE ACT 1975 THE MUNICIPAL ELECTIONS ACT 1977

THE CORPORATION OF THE TOWN OF ERAMOSIA IN THE COUNTY OF WELLINGTON BY-LAW NO. 24-1978

A by-law of the Corporation of the Township of Eramosa in the County of Wellington for the submission to a vote of a question under the provision of The Municipal Elections Act 1977 to the qualified electors in the municipality;

WHEREAS at the time of the coming into force of The Ontario Temperance Act, a by-law dated 1910 was in force within the limits of the municipality prohibiting the sale of liquor by retail therein;

AND WHEREAS by Section 50 of Regulation 100/75 under The Liquor Licence Act 1975, the issuance of a liquor licence to premises located in a municipality is confined to those municipalities where an affirmative vote has been taken on the relevant questions as stated in the Regulations under The Liquor Licence Act;

AND WHEREAS under Section 122 of The Municipal Elections Act, the Council of a municipality may submit to a vote of the persons qualified to be entered on the voters' list and to vote at elections in the municipality any question (or questions) set forth in The Liquor Licence Act 1975;

AND WHEREAS the Council considers it expedient and desirable to submit to a vote of the persons qualified to vote thereon as aforesaid the following question:

ARE YOU IN FAVOUR OF THE SALE OF SPIRITS, BEER AND WINE UNDER A LOUNGE LICENCE FOR CONSUMPTION ON LICENSED PREMISES?

AND WHEREAS The Council considers it expedient and desirable that the vote on the question shall be taken upon the day upon which, under The Municipal Elections Act, a poll will be held at the next election of members to Council;

AND WHEREAS it is necessary to provide by by-law for the submission of the said question to the persons qualified to vote thereon and for the taking of their votes thereon;

THEREFORE, the Council of the Corporation of the Township of Eramosa in the County of Wellington enacts as follows:

1. Under The Municipal Elections Act 1977 there is hereby submitted to a vote of the persons qualified to be entered on the voters' list and to vote at elections in the municipality, the following question pursuant to the Regulations under The Liquor Licence Act 1975:

ARE YOU IN FAVOUR OF THE SALE OF SPIRITS, BEER AND WINE UNDER A LOUNGE LICENCE FOR CONSUMPTION ON LICENSED PREMISES?

2. The vote shall be taken upon the day upon which, under The Municipal Elections Act 1977, a poll will be held at the next election of members to Council.
