### Stylish cottage design

This cottage plan is a good basic design, which could easily be used as a small family home.

The large glass area on the front, will make the most of a view, and looks quite attractive with the full width balcony.

The driveway in the illustration is shown for a front entrance, but the design is better suited to a back driveway. The front of the house should face the view, however this isn't always practical.

. The carport has a storage area adjacent to it, ideal for storing lumber, firewood, or garden tools in an enclosure that can be securely locked.

From the carport, the front entrance through the sliding glass doors of the living room is just steps away. The living, dining and kitchen areas seem extra spacious with the sloping ceiling in these areas.

This family area is central fireplace. Finish it in natural fieldstone, brick or rough plaster, to frame the warm fire-a great comfort on a cool evening. Also the fireplace is in the centre of the house, and its warmth will be radiated throughout, hours after the fire has extingulshed itself.

The kitchen is compact but V3L 1A6

efficient in design, a real plus in a house this size. Further, it's close to the living and dining areas, a convenience for meals and snacks.

The three bedrooms are a necessity for a cottage plan, with the utlimate in privacy for each guest. The master bedroom has a three piece ensuite, an unusual extra in a plan of this size. The other bathroom services the other two bedrooms.

The furnace, and hot water heater, as well as the washer and dryer are located in the central fireplace core. Overall, this is a very livable plan utilizing the available space to advantage.

# Ontario's Workplace

Since 1970 working women in this province have had the benefit of pregnancy leave. They can have a child and then return to their job with the same employer without loss of seniority of other benefits.

The job of any woman, married or unmarried, is secure if she has been employed by a company continuously for at least one year and 11 weeks.

Under The Employment Standards Act, a flexible 17week unpaid leave of absence is available for women who qualify. The leave may begin at any time during the 11 weeks prior to the estimated date of delivery and the employee is entitled to a fixed minimum of six weeks leave after delivery. A shorter leave after the delivery will be allowed only with the approval of the woman's physician. A longer post natal leave is dependent on the number of weeks taken before the birth, i.e., four weeks prenatal leave would allow for 13 weeks post natal leave. The employee must apply for pregnancy leave in writing, giving her employer at least two weeks notice. A medical certificate indicating the estimated delivery date must accompany her request.

When the leave of absence has expired the woman can return to the same position without loss of seniority or other benefits she had accrued to the start of her leave. Even if her original position is not available she is guaranteed reinstatement in a similar job.

Pregnancy leave is available to all women employees after 12 months and 11 weeks service whether they are students, part-time or full time employees.

Unemployment Insurance benefits are available for part of the leave. A pamphlet entitled "Maternity" is provided by every UIC office.




