No Sprackman plaza hearing until late spring

Halton Hills and Landawn Shopping Centres won't battle it out before the Ontario Municipal Board about plans to build a plaza on the east side of Acton until at least late May or June.

After council rejected his application for a zoning and official plan amendment for a large plaza to be built on land at the corner of Churchill Rd. South and Highway 7 in 1979 developer Jerry Sprackman, president of Landawn Shopping Centres, asked Queen's Park to send the case to the OMB.

Halton Hills planning board chairman Mike Armstrong said in an interview this week he has been talking to Sprackman and the developer has decided to ask the OMB to defer the hearing until at least the spring.

Halton Hills earlier attempted to have the province rule there shouldn't be a hearing, but lost that bid to clear up the matter.

The minister of housing decided there should be a hearing and referred the matter to the OMB. The OMB has yet to set a hearing date.

In previous conversations with Armstrong in the past couple of months Sprackman blated he might withdraw his case entirely the regional councillor said, and the developer also wrote and asked if it would be of any use for him to appear before council to discuss the matter. Council declined to invite Sprackman for another discussion of the issue.

Sprackman has objected to some rezoning the town has approved since turning him down, including rezoning of a parcel of land on Acton's north-west fringe for industrial development.

Armstrong sald he talked Sprackman into asking the OMB for a deferral until late May or June in the event the hearing is called for this winter because the town is in the process of conducting an urban boundary and planning study for the Acton area through a consulting firm.

Planning board chairman noted unless there are changes made by Queen's Park with regard to Acton's sewage treatment plant limits then existing (Continued on page B 11)

phases, is a brand new IGA supermarket which would be three of four times larger than the existing store. This new IGA would be built on the site of the Dominion Hotel which burned down in August of 1979 and Fread-Kassian acquired last October at a public auction.

The first phase would also involve several retail

Phase two, which would be built to the north of the hotel site now used by the BIA for a parking lot, would be a strip plaza of stores.

Fread estimated there would be 10,000 to 12,000 square feet of stores for rent when both sections of this development are completed.

Drawings have been done and some square footages for the IGA and stores established, but not nalled down because the configuration of the development could be changed still during discussions with the municipality regarding rezoning and site development.

There would be parking for 96 cars when the entire development is completed.

"It's a whole new start towards rejuvenation of downtown Acton," Fread said, agreeing the project is a very major commercial development for the

While it will be something of a strip plaza, Fread noted the architecture will reflect an older style, its character will fit in well with downtown, and it won't be a cheap looking strip plaza. He very much wants the development to be a quality project.

Through Fobert Real Estate negotiations have begun with three prospective tenants for the stores, including a trust company. Fread said the size and number of stores is flexible, based on how large tenants want their stores to be, but expects there will be about eight outlets in addition to the IGA. Fread said they are looking for quality businesses for the plaza and the firms they are talking to are well known names.

Besides the Dominion Hotel site Fread-Kassian have acquired property from adjacent landowner Dave Lindsay as well as the old boarded up home to the north. They have made arrangements to purchase another piece of property to the north of the hotel site where lawyers offices are now located.

Phase two of the project won't proceed until the first is finished and completely leased. Frend sald he hopes Halton Hills council will

expedite the rezoning so work can begin in the spring.

Board postpones decision on firing of convicted teacher

Keith Black's future as a teacher is in the hands of the 20 Halton Board of Education trustees.

Trustees will decide next Wednesday (January 21) whether Black, who was convicted of theft in a case which has nothing to do with his school work, will continue to hold a job with the Halton board. The Black matter is the first major test of the new

Halton Board of Education since the fall election. Trustees postponed a decision concerning Black's job at Acton High School Thursday. However, they

listened behind closed doors to arguments from three representatives of 250 or so Acton and Rockwood residents who drove to the Burlington meeting.

Crowd members talked quietly, standing elbow to

elbow, in the foyer of the board's central administration office for about an hour before the board invited ministers Charles Beaton, John Robertson and Black's lawyer David Smith into the

All of the board's hour long private meeting was devoted to the Black case.

The board listened to the advice of its lawyer during the meeting. At least one trustee had a copy of the court transcript dealing with Black's sen-

Three days before Christmas Black was given a suspended sentence and placed on three years probation by Wellington County Court Judge J.D. Sutherland for a technical theft of cattle. Black, who ran a feeder lot farm in Eramosa Township, sold about \$160,000 worth of cattle which belonged to another man.

Black, who is head of the social science department at Acton High School, learned by registered letter on December 30 that the board's staff is recommending the board fire him and also that he lose his teacher's certificate.

Halton Superintendent of Instruction Ray Stoness, over whose signature the recommendations were made, said Thursday his decision was based on a legal interpretation of the Education Act. Moreover, he told reporters, his decision was supported by members of the board's executive (Continued on page B 11)


